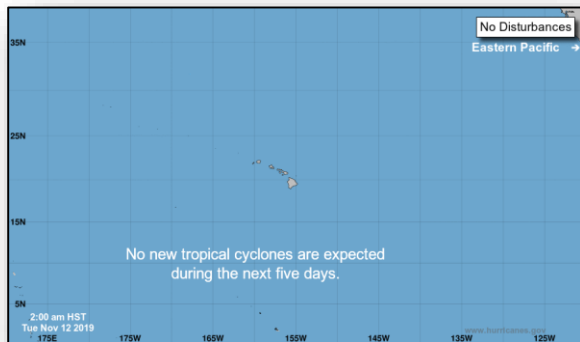
Significant Incidents or Threats: Winter weather – [Great Lakes into New England](#)

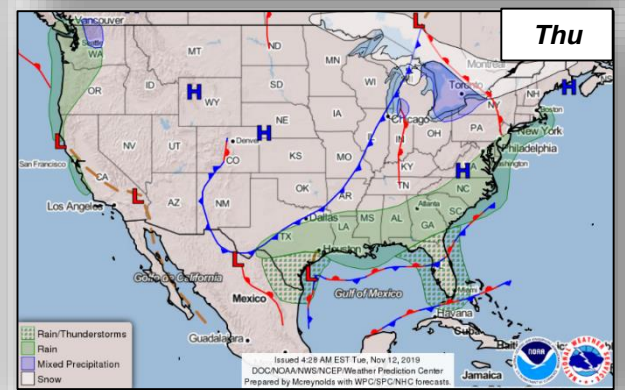
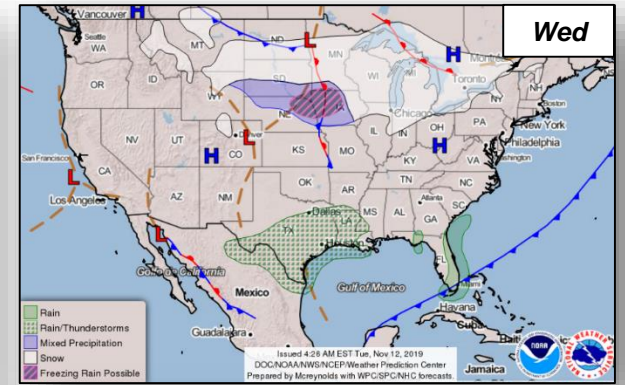
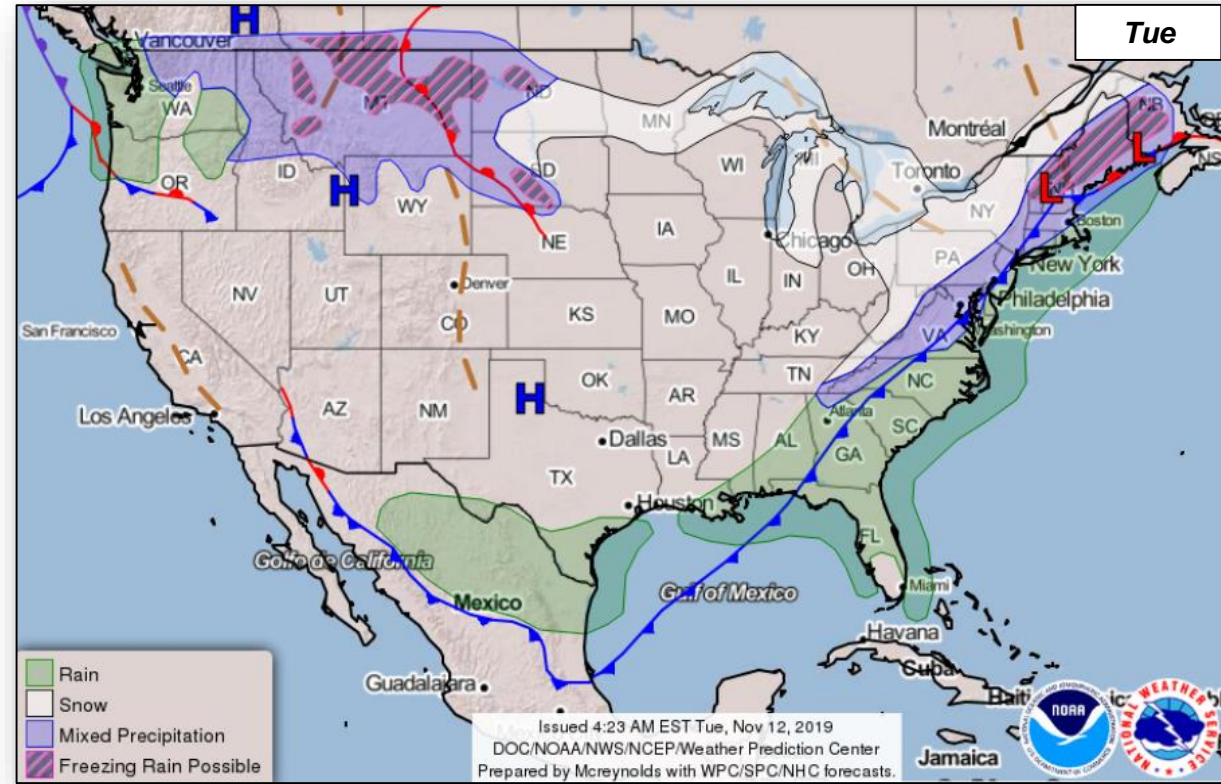
Disturbance 1 (as of 7:00 a.m. EST)

Tropical / Sub-Tropical Cyclone: Depression | Storm | Hurricane | Post-Tropical Cyclone / Remnants

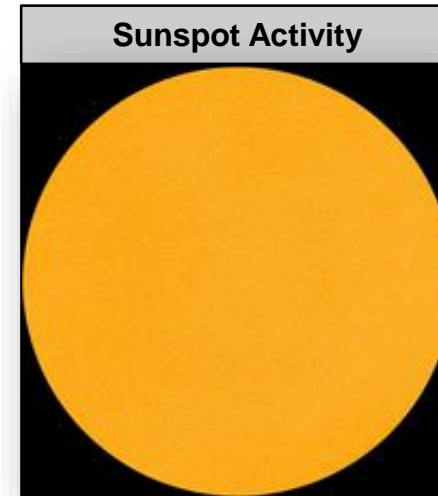
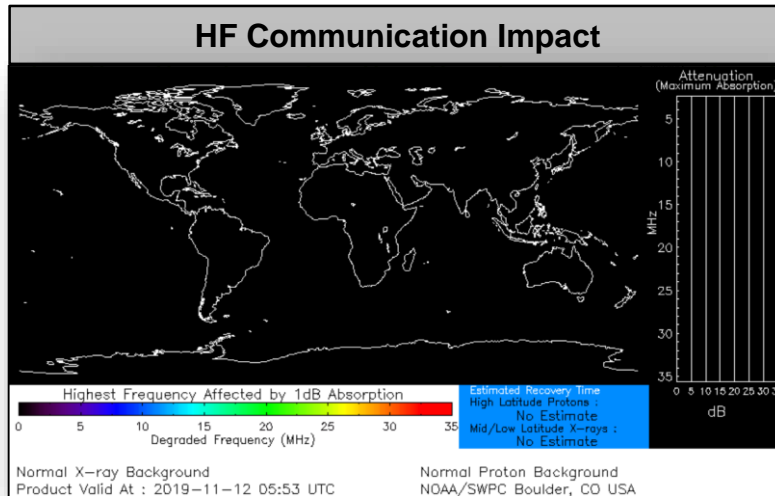
