Error When Finalizing Private School Service Plan

Districts have reported a 90-day timeline error when finalizing PSSP's that are not Initial. To bypass this error, please use the steps below. Please remember that if the student is an Initial Referral and the EC process has exceeded 90 days, a Delay Reason will be required. Using this method to bypass the delay reason will cause an error on the upcoming Indicator 11 and Indicator 12 counts which will require you to go back and save a Delay

Go to Data Collection
Click on the Part B Referral tab
Select Delay Reason - INO5 - Other
Click Save
Navigate to PSSP - Click Save and Continue on the Meeting Information screen
Finalize the PSSP
Go Back to Data Collection
Click on the Part B Referral tab
Select Delay Reason - Blank
Click Save

After completing these steps, the student's PSSP event will show in Student History and the student will appear on Child Count if the dates are appropriate for the count period.
