- Orders shipped to student homes must include a parent name for delivery contact and <u>NOT</u> a student name.
- Orders shipped directly to school locations will be held and processed later, once school buildings reopen.
- When submitting an NCAPH order, indicate in the email message if the order is being shipped to a student home or school
