

FEMA Daily Operations Briefing Monday, July 13, 2020 8:30 a.m. ET

National Current Operations & Monitoring



Significant Incidents or Threats:

- Severe thunderstorms possible Central/Northern Plains and Upper Mississippi Valley
- Heavy rain and flash flooding possible Northern Plains, Upper Mississippi Valley, and the Northeast
- Critical fire weather possible Central Great Basin and Southwest
- COVID-19

Tropical Activity:

- Atlantic: No new tropical cyclones expected during the next five days
- Eastern Pacific:
 - Post-Tropical Cyclone Cristina FINAL
 - Disturbance 1 Medium (60%)
- Central Pacific: No new tropical cyclones expected during the next five days
- Western Pacific: No activity affecting U.S. interests

Declaration Activity:

- Major Disaster Declarations Approved Alabama (2), Arkansas (1)
- FMAG Approved Road 11 Fire, WA

<u>Post-Tropical Cyclone Cristina</u> (Advisory #26 as of 11:00 p.m. ET) FINAL

- 1,075 miles W of the southern tip of Baja California, Mexico
- Moving W at 19 mph
- Maximum sustained winds 35 mph
- Expected to dissipate in a few days
- This is the last public advisory issued by the NHC

Disturbance 1 (as of 8:00 a.m. ET)

- Located less than 200 miles SSE of Socorro Island, Mexico
- Moving W at 20 mph
- Still has the potential to become a tropical depression in the next day or so
- Formation chance through 48 hrs.: Medium (60%)
- Formation chance through 5 days: Medium (60%)

Current Situation:

- Fire began July 11 and is burning on state and private land 24 miles east of the city of Chelan (pop 4,000)
- Threatening homes in and around town of Mansfield (pop 330), publicly owned power lines, telephone lines, a K-12 school, a fire station, a municipal airport, and ecological resources in the area
- Fire has destroyed power and telephone lines and several outbuildings
- Mandatory and voluntary evacuations in effect

Response:

- FMAG approved July 12
- WA EOC at Full Activation (COVID-19)
- NWC & Region X / Bothell MOC continue to monitor



COVID-19 Update



Situation: Upward trajectory in COVID-19 case count continues across 14 states, 21 states in a plateau status. 31,403 Federal employees deployed / activated; 2,292 FEMA employees deployed.


Nationwide Testing: 40,045,940 cumulative as of July 10.

COVID-19 positive cases continue to increase globally (CDC COVID-19 Response Update as of July 12)

- Confirmed Cases of COVID-19
 - o United States: 3,236,130 (+62,918)
 - o Worldwide: 12,322,395 (+219,983)
- Deaths caused by COVID-19
 - United States: 134,572 (+906)
 - Worldwide: 556,335 (+5,286)


Response:

- NWC, all RWCs, and MOCs are monitoring










Severe Weather Outlook









Fire Weather Outlook









