### National Current Operations and Monitoring **W** FEMA

#### Significant Incidents or Threats:

- Isolated to Scattered Dry Thunderstorms Central Great Basin to Northern Plains
- Critical Fire Weather Northern California and Central Great Basin
- Industrial Fire TX
- Earthquake CA
- COVID-19

#### **Tropical Activity:**

- Atlantic:
  - Disturbance 1: High (80%)
  - Disturbance 2: High (90%)
  - Disturbance 3: Low (20%)
- Eastern Pacific:
  - Tropical Cyclone Genevieve (CAT 3)
  - Disturbance 1: Medium (50%)
- Central Pacific:
  - Disturbance 1: Low (10%)
- Western Pacific: No activity affecting U.S. interests

### Tropical Outlook – Atlantic



#### Disturbance 1 (as of 8:00 a.m. ET)


- Located over the eastern Caribbean Sea
- Moving W at 20 mph
- Conditions could become more conducive for the development of a tropical depression later this week
- Formation chance through 48 hours: Medium (40%)
- Formation chance through 5 days: High (80%)

#### Disturbance 2 (as of 8:00 a.m. ET)

- 1,000 miles E of the Lesser Antilles
- Moving W to WNW at 15-20 mph
- Tropical depression likely to form within the next two days
- Formation chance through 48 hours: High (90%)
- Formation chance through 5 days: High (90%)

#### Disturbance 3 (as of 8:00 a.m. ET)

- Large area of showers located over Guinea, Africa
- Moving W to WNW at 15-20 mph
- Conditions marginally conducive for development
- Formation chance through 48 hours: Low (near 0%)
- Formation chance through 5 days: Low (20%)



### Tropical Outlook – Eastern Pacific



#### <u>Tropical Cyclone Genevieve</u> (CAT 3) (Advisory #12 as of 5:00 a.m. ET)

- 190 miles S of the southern tip of Baja, California
- Moving NNW at 10 mph
- Maximum sustained winds 115 mph
- Little change of strength is expected today followed by some weakening
- Hurricane force winds extend 35 miles
- Tropical-storm-force winds extend outward up to 140 miles

#### Disturbance 1 (as of 8:00 a.m. ET)

- Expected to form later this week several hundred miles W of the southwestern coast of Mexico
- Conditions appear favorable for some development over the weekend
- Formation chance through 48 hours: Low (near 0%)
- Formation chance through 5 days: Medium (50%)







### Tropical Outlook – Central Pacific



#### Disturbance 1 (as of 8:00 a.m. ET)

- 1,120 miles SW of Honolulu, HI
- Conditions are not expected to be conducive for development
- Formation chance through 48 hours: Low (near 0%)
- Formation chance through 5 days: Low (10%)

### Industrial Warehouse Fire – Grand Prairie, TX




#### **Current Situation:**

- Industrial fire at the Poly-America Building reported at Aug 19, 2:00 a.m. ET near Grand Prairie, TX (pop.195k)
- Facility burning polyethylene which is used to produce plastic bags
- The Emergency Manager from Grand Prairie County Fire Dept. requested an IMAAC activation
- Media reporting voluntary evacuations in effect for vicinity of Grand Prairie, TX
- Primary hazard of plume is inhalation of soot and particulates causing general irritations
- Grand Prairie County Fire Dept. is on scene and handled at the local county level
- Though the fire was reported to be threatening utility poles that may affect power to surrounding areas
- Currently there no reports of injuries

#### Response:

- Region VI RRCC at Level III
- TX EOC at Partial Activation (COVID-19)
- FEMA NWC requested IMAAC Activation on behalf of Grand Prairie County Fire Dept.
- Region VI RWC and NWC continue to monitor





### COVID-19 Update



Situation: Upward trajectory in COVID-19 case count continues across 8 (+1) states, with 2 (-2) states in a plateau status, and 46 (+1) states on a downward trajectory. 22,614 (-1,185) Federal employees deployed / activated; 1,986 FEMA employees deployed.


Nationwide Testing: 73,563,539 (+753,161) cumulative as of Aug 18

COVID-19 positive cases continue to increase globally (CDC COVID-19 update as of Aug 18)

- Confirmed Cases of COVID-19
  - o United States: 5,422,242 (+40,117)
  - o Worldwide: 21,549,917
- Deaths caused by COVID-19
  - o United States: 169,870 (+520)
  - o Worldwide: 767,158

#### Response:

- NRCC at Level I
- Regions I, II, III, V, VI, VII, & X RRCCs at Level III
- Regions IV, VIII, & IX RRCCs are rostered
- Regions VII, VIII & IX COVID-19 response being worked from the Virtual JFO
- NWC, all RWCs, and MOCs are monitoring



#### **Current Situation:**

- Fires began August 18 and is burning on state and private land
- Fire is threating homes in the Carmel Valley area, Monterey County, California (pop. 980)
- Mandatory and Voluntary evacuations are in progress
- Evacuation centers established in Carmel Valley and Salinas
- Threatening agricultural areas and high voltage transmission lines serving Big Sur

#### Response:

- FMAG approved Aug 19
- Region IX LNO to Cal EOC today at 10 am ET
- CA EOC at Full Activation (Civil Unrest and COVID-19)
- Region IX RWC and NWC continue to monitor








### Severe Weather Outlook






