Shapiro, Old Security Financial Group, Inc., Donald Anthony Mackenzie, Robert S. Davis, Jr. aka Lute Davis, BP Financial & Tax Design Group and Brett Pittsenbargar, Order No. ENF-15-CDO-1740, said information being a material fact; and

PARAGRAPH TWO

intentionally failing to disclose that on or about May 4, 2015, the Massachusetts Securities Division entered an administrative order, In the Matter of Woodbridge Mortgage Investment Fund 1, LLC, Woodbridge Mortgage Investment Fund 2, LLC, and Woodbridge Mortgage Investment Fund 3, LLC, Docket No. E-2015-0039 said information being a material fact; and

PARAGRAPH THREE

intentionally failing to disclose Defendant was receiving commissions and other payments from the Woodbridge Group of Companies, LLC, and its affiliates, said information being a material fact; and

PARAGRAPH FOUR

intentionally failing to disclose investor funds were used to purchase investments with the Woodbridge Group of Companies, LLC, and its affiliates, said information being a material fact; and

PARAGRAPH FIVE

intentionally failing to disclose Defendant was the sole principal of Ironbridge Asset Fund, LLC, said information being a material fact; and

PARAGRAPH SIX

intentionally failing to disclose Defendant was the sole principal of Ironbridge Asset Fund 2, LLC, said information being a material fact; and

PARAGRAPH SEVEN

intentionally failing to disclose that on or about January 3, 2008, Defendant filed for chapter 7 bankruptcy in the U.S. Bankruptcy Court, District of Colorado, said information being a material fact; and

PARAGRAPH EIGHT

knowingly and intentionally representing that no officer of Ironbridge Asset Fund, LLC, or Ironbridge Asset Fund 2, LLC, had faced personal insolvency or filed for bankruptcy in the past ten years, said information being a misrepresentation of a relevant fact; and

All of said amounts were obtained pursuant to one scheme and continuing course of conduct, and the aggregate amount that was obtained was \$100,000.00 or more;
