

- Western Pacific: No activity affecting U.S. interests




Hurricane Delta SATELLITE LOOP




Hurricane Delta FORECAST TRACK




Hurricane Delta MOST LIKELY ARRIVAL OF TS WINDS




Hurricane Delta HURRICANE WIND PROBABILITY




Hurricane Delta 5 DAY RAINFALL

Hurricane Delta – Preparations/Response




Situation: Hurricane Delta threats portions of the Gulf Coast. In anticipation, national and regional assets have deployed.

 - FL: EOC at Full Activation (TC Sally/COVID-19)




Inland Flood Threat






Fire Weather Outlook

COVID-19 Update



<u>Situation:</u> Upward trajectory in COVID-19 case count continues across 34 (+1) states/territories, with 6 (+2) states/territories in a plateau status, and 16 (-3) states/territories on a downward trajectory. 16,763 National Guard deployed / activated; 1,253 (-13) FEMA employees deployed. (COVID-19 SLB, as of Oct 6)

Nationwide Testing: 119,383,314 (+886,802) cumulative (COVID-19 SLB, as of Oct 6)


COVID-19 positive cases continue to increase globally

- Confirmed Cases of COVID-19
 - o United States: 7,436,278 (+39,548)
 - Worldwide: 35,274,993 (+247,447)
 - Deaths caused by COVID-19
 - United States: 209,560 (+361)
 - o Worldwide: 1,038,534 (+3,697)

(COVID-19 Response Update, as of Oct 6)

Response:

- NRCC conducting COVID response operations
- Regions I, II, III, V, VI, & X RRCCs at Level III
- Regions IV, VII, VIII, & IX RRCCs are rostered
- Regions VII, VIII, & IX COVID-19 working from the Virtual JFO
- NWC, all RWCs, and MOCs are monitoring


