- Western Pacific: No activity affecting U.S. interests



Tropical Outlook – Atlantic




Tropical Depression Eta (Advisory #19 as of 4:00 a.m. ET)

- 90 miles S of La Ceiba, Honduras
- Moving WNW at 8 mph
- Maximum sustained winds 30 mph
- Will likely degenerate to a remnant low or trough of low pressure this morning; however, re-intensification is forecast once the center of Eta moves over the northwestern Caribbean Sea
- On the forecast track, the center is expected to move across Honduras through this afternoon, and emerge over the Gulf of Honduras by tonight
- Forecast to approach the Cayman Islands and Cuba this weekend



Tropical Storm Odalys (Advisory #7 as of 4:00 a.m. ET)

- 865 miles WSW of southern tip of Baja California
- Moving WNW at 9 mph
- Maximum sustained winds 50 mph
- Expected to become a remnant low on Friday
- Tropical storm force winds extend 150 miles

COVID-19 Update



<u>Situation</u>: Upward trajectory in COVID-19 case count continues across 42 (-3) states/territories, with 3 (-1) jurisdictions in a plateau status, and 11 (+4) jurisdictions on a downward trajectory; 1,251 (-2) FEMA employees deployed. (COVID-19 SLB, as of Nov 4)


Nationwide Testing: 152,599,729 (+1,542,836) cumulative (COVID-19 SLB, as of Nov 4)










Fire Weather Outlook











