‘Highlights that border procedures currently constitute exceptions to the legally defined rule that asylum applicants have a right to enter the territory of a Member State; notes that many applications for international protection are made at the border or in a transit zone of a Member State prior to a decision on the entry of the applicant; notes that in those cases Member States may provide for border procedures only in the cases exhaustively set out in the Articles 31(8) and 33 of the APD and in accordance with the basic principles and guarantees of Chapter II of the APD; notes that the transposition and application of border procedures under the APD varies between Member States, resulting in a lack of uniformity across the EU; takes note that most Member States apply border procedures only in a small number of cases, and that several Member States generally refrain from using border procedures; highlights, however, that three out of the seven Member States examined in the EPRS European Implementation Assessment apply border procedures beyond the grounds provided for in Article 43 of the APD, and calls on them to refrain from doing so;’
