Hazard Monitoring

- Severe thunderstorms possible- Southern/Central Plains
- Heavy rain and flash flooding possible - Southern/Central Plains
- Tropical Activity:
 - Eastern Pacific: Disturbance 1: Low (30%); Disturbance 2: Medium (50%)
 - Western Pacific: Invest 90W: High; Invest 99W: Medium

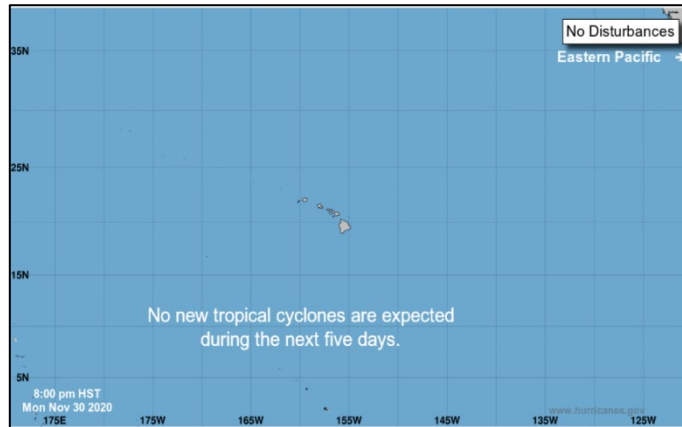

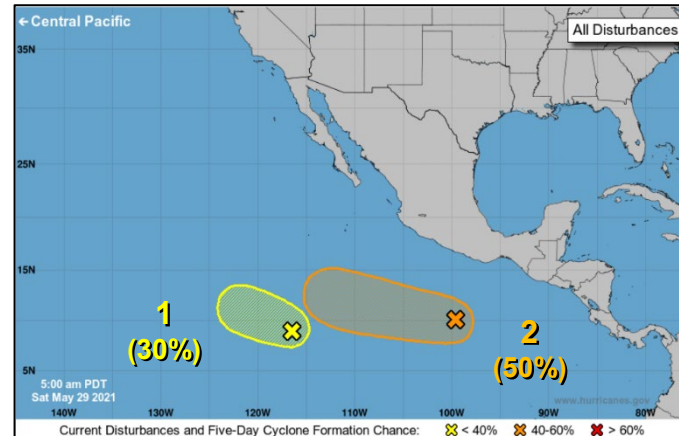

Disturbance 1 (as of 8:00 a.m. ET)

- 1,000 miles SSW of southern tip of Baja California peninsula
- Moving W at 5-10 mph
- Some slow development is possible next few days
- 48-hour formation chance: Low (20%)
- 5-day formation chance: Low (30%)

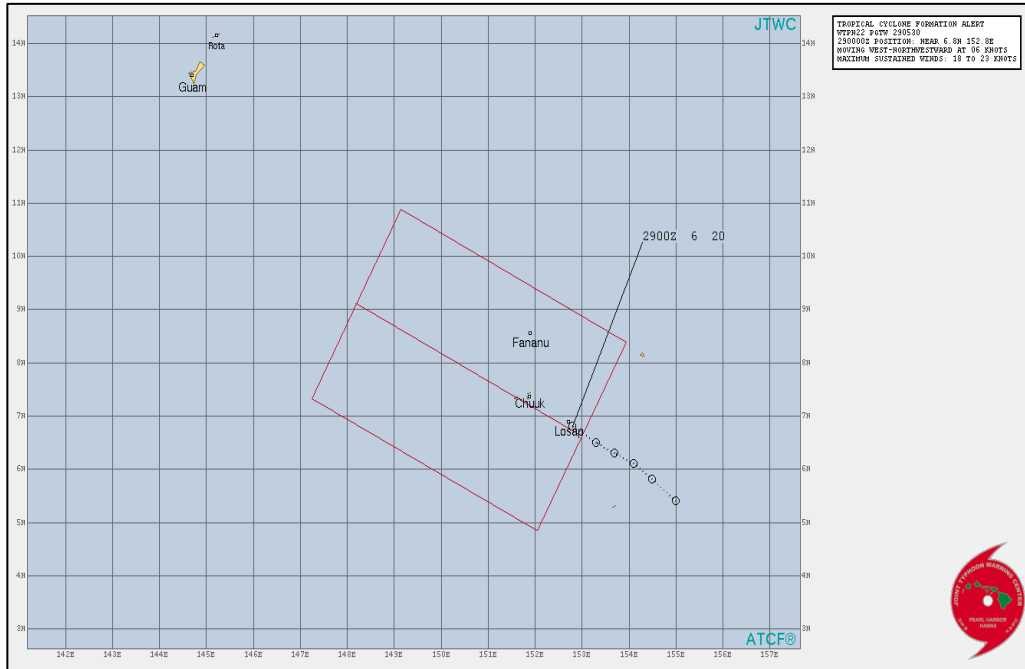
Disturbance 2 (as of 8:00 a.m. ET)

- Several hundred miles S of Acapulco, Mexico
- Moving W to WNW at 10 mph
- Gradual development possible next several days
- 48-hour formation chance: Low (20%)
- 5-day formation chance: Medium (50%)



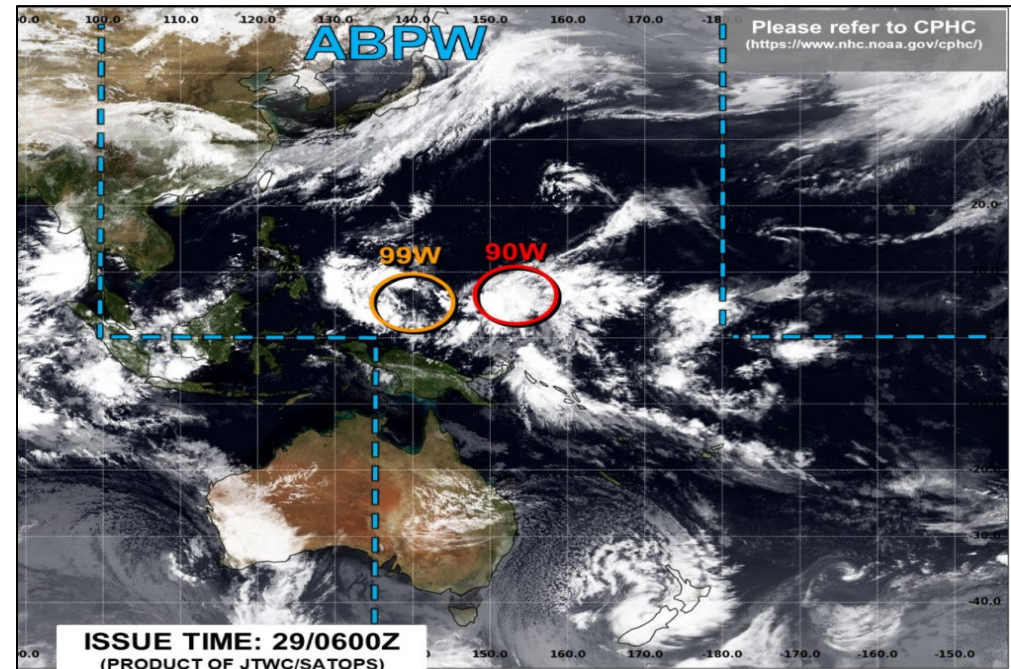

Tropical Outlook – Western Pacific



Invest 90W (as of 2:00 a.m. ET)

- 715 miles SE of Guam
- Moving WNW at 7 mph
- Maximum sustained winds 20-26 mph
- May pass close to Guam as a tropical depression early next week and bring heavy rainfall over Guam
- 24-hour formation chance: High



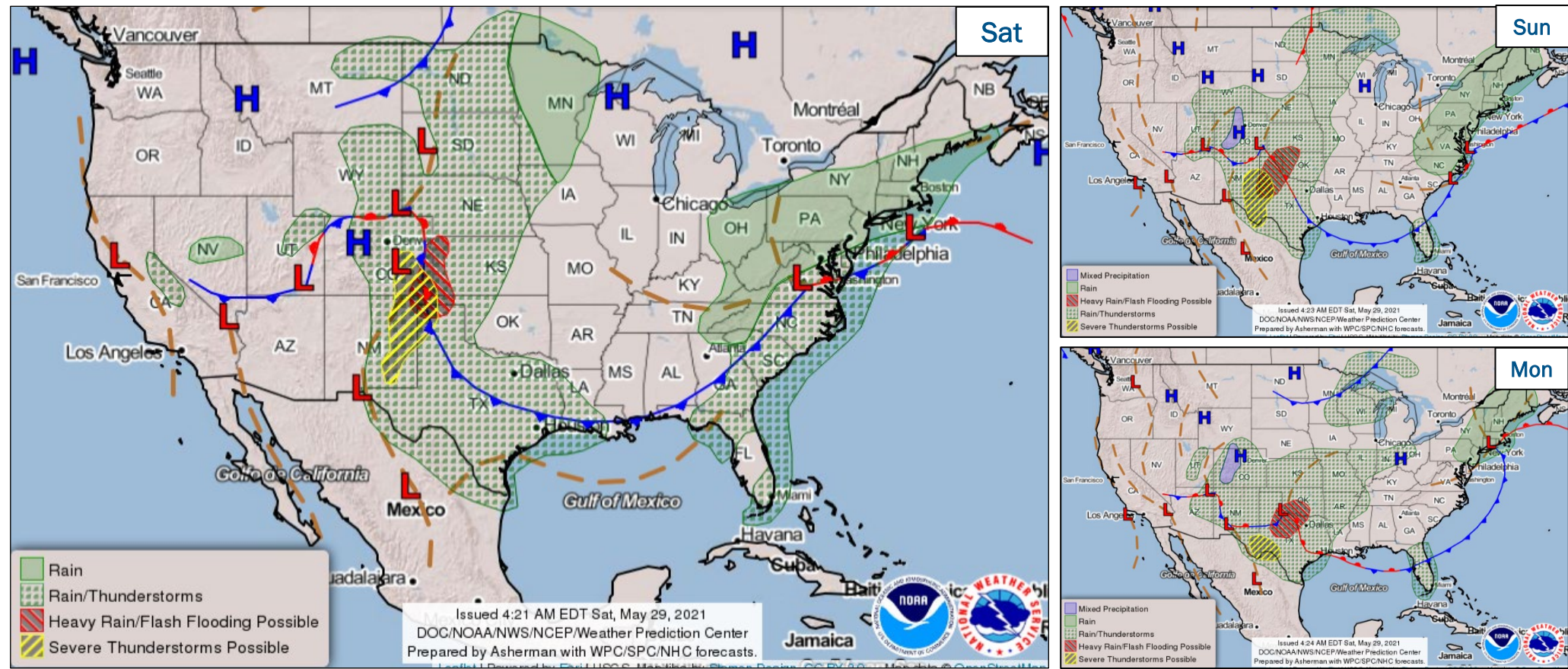
Invest 99W (as of 2:00 a.m. ET)

- 85 miles ESE of Republic of Palau
- Moving WNW
- Maximum sustained winds 17-23 mph
- 24-hour formation chance: Medium



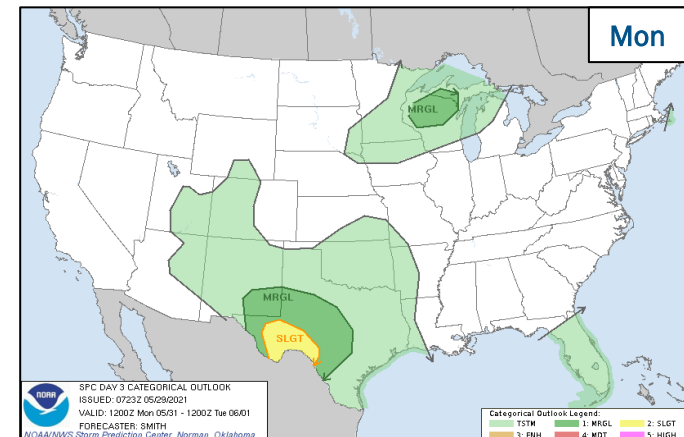
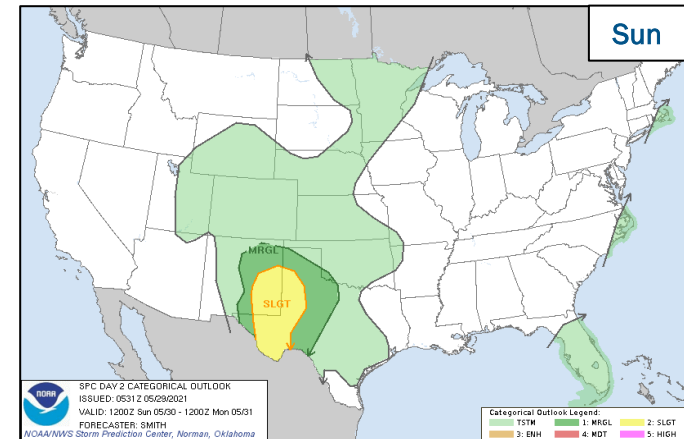
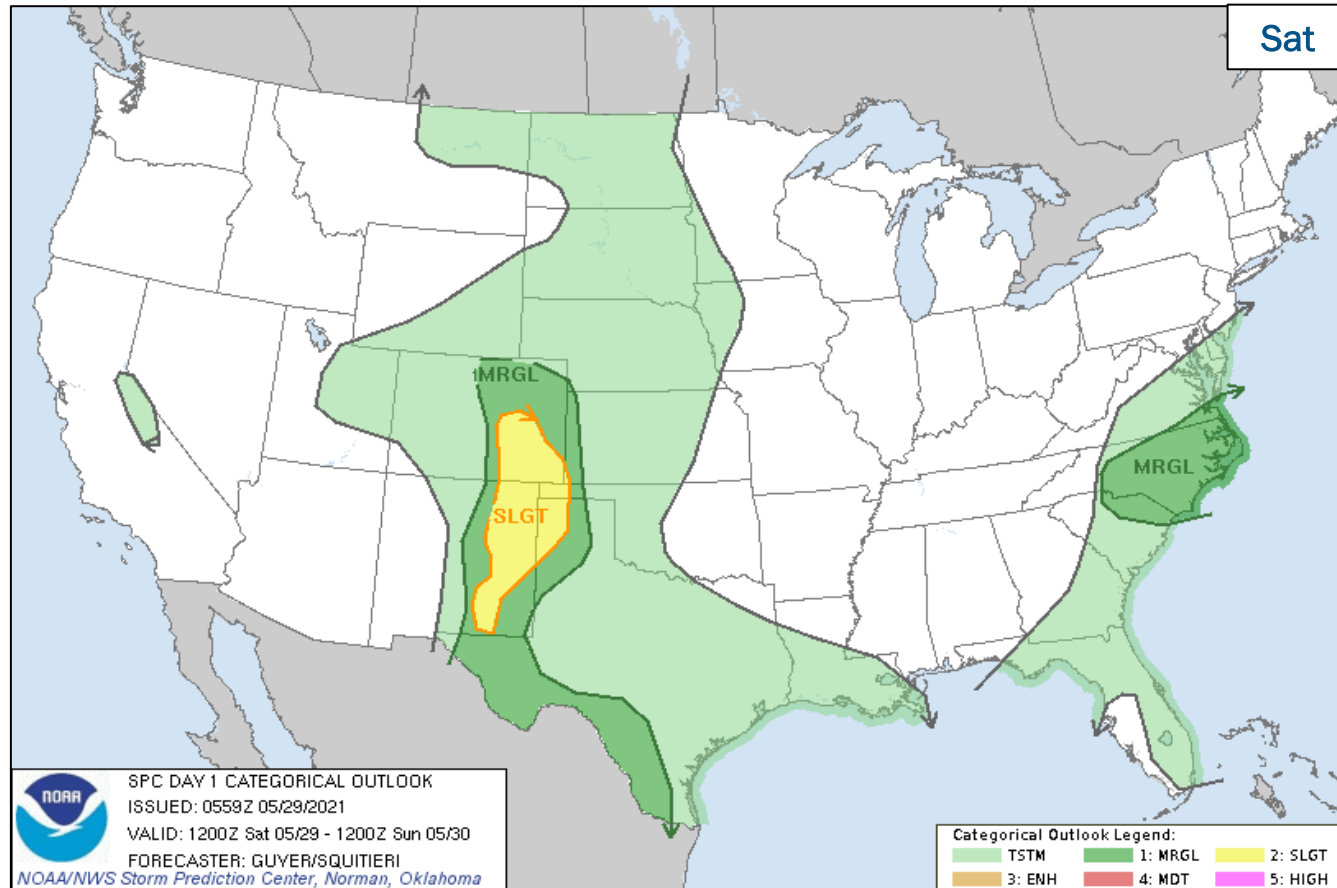

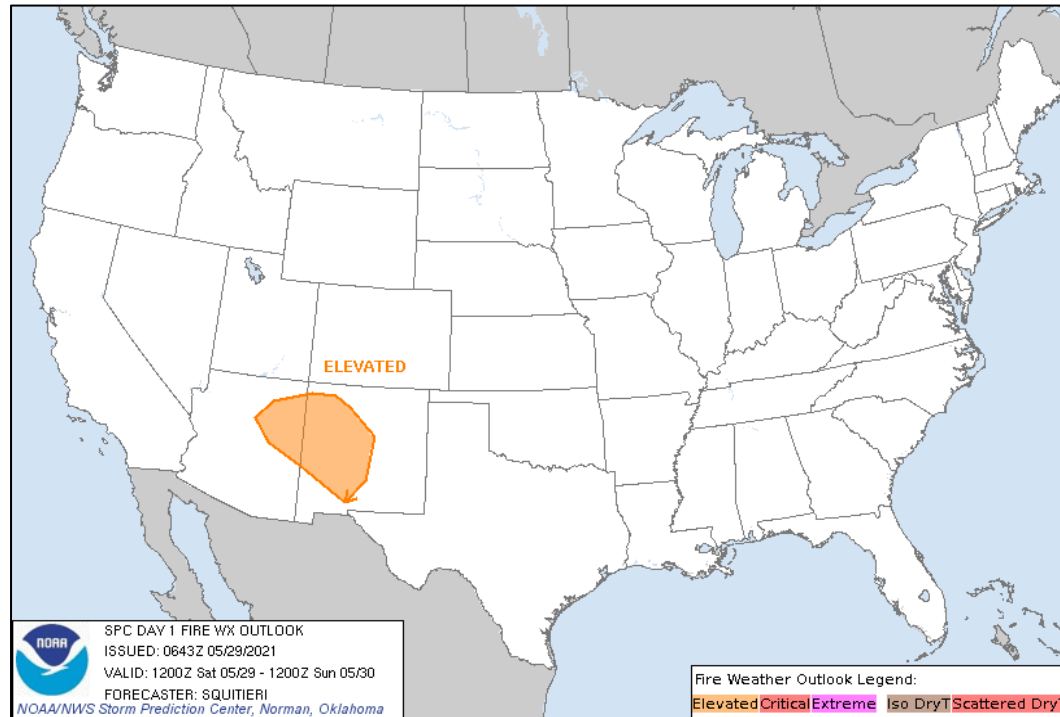
Precipitation & Excessive Rainfall



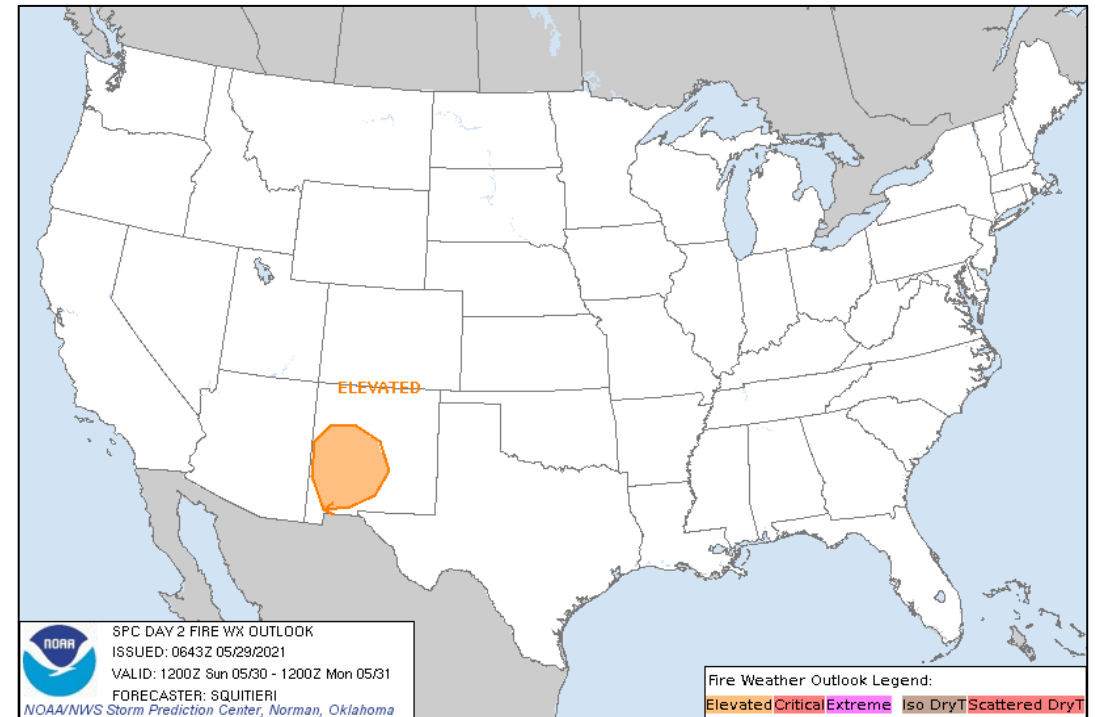
