## The following is a message from our ECATS vendor, PCG.:

We apologize for the system performance issues that DPI staff and LEA users experienced over the last week. We understand the importance of the ECATS system to educators in the field and have made resolution of this issue a top priority of our technical team. The problem was related to a significant increase in system usage that impacted our storage.

Last week, PCG technical team added additional hardware capacity to support the increased volume to address system performance issues. Over the weekend we increased capacity at the database level, and reconfigured drives for improved performance. We are continuing with make further adjustments, including additional hardware capacity to handle the load.

We value a positive user experience, and we will not rest until we have system performance back to acceptable levels. If you continue having issues, please have your ECATS Designee submit a ZenDesk ticket.

## **Significant Disproportionality**

The EC Division has decided due to COVID-19 and the OSEP requirement to include students ages 3-5 in all current and future disproportionality calculations, to extend a "grace year" to any district who has Significant Disproportionality for the first time in 2020-21. This means that districts who have four (4) consecutive years of disproportionality and have not made reasonable progress will remain on the Mandatory list while districts who have three (3) years or less will remain on the Warning List. #### **NEW OPPORTUNITY: Program Compliance Cohort**

The EC Division would like to provide a new professional learning opportunity through a Program Compliance Cohort. Participants in this cohort are best described as members of the local EC Leadership Team tasked with supporting the EC Director with administering and supervising local special education programs regardless of specific job title (Program Specialist, Compliance Specialist, etc.).

The goal of the cohort is to provide tailored and customized support to expand upon the universal professional learning provided by the EC Division. It is particularly intended to support participants with the application of federal regulations and state policies when decisions are being made at the local central office and implemented at the school and classroom level. Participants must be recommended by the local EC Director/Coordinator/Supervisor in order to participate.

This cohort is not the same as New Directors Leadership Institute (NDLI) or Charter Exceptional Leadership Institute (CECLI) as the goals and objectives for each of these engagements are different. The Program Compliance Cohort is a one-year commitment meeting virtually once a month for three hours. It will require evidence of learning to demonstrate the application of content provided and to facilitate the networking of strong leadership practices. CEUs will be awarded for participation.

In order to appropriately plan this opportunity, the completion of a short survey (six questions with estimated completion time of less than five minutes) is requested.

## **UPDATE: ECATS Change - "Per Reporting Period"**

As communicated in the May 19, 2021, Weekly Update, the EC Division is organizing a technical assistance package to support the transition from the use of "Per Reporting Period" as an option to describe the frequency of services.

The technical assistance package is being reviewed internally with an anticipated release to EC Directors next week in the June 9, 2021, Weekly Message. During the week of June 14, 2021, the same technical assistance package will be released through other EC Division listservs and posted to the EC Division website. Any deviation from this plan will be communicated through the Weekly Message.

Please be reminded that the EC Division is not requiring LEAs to review and revise current IEPs in anticipation of this change. Based on the concerns expressed from the field, the sunset date for removing "Per Reporting Period" from ECATS will now be September 15, 2021 rather than July 1, 2021. With the extension of time and the aforementioned technical assistance package, it is hoped this will support PSUs to a smoother transition for this change.
