## Graduates for the 2020-21 School Year and Exit Data

NCDPI and PCG are working with PowerSchool to determine when graduation status is complete for the 20-21 school year. The process to update graduation data in ECATS will take place after the August deadline for entry of graduation data into PowerSchool. Once the file is processed, students who have graduated will be exited in ECATS. After that point, districts will be able to select the Modified Exit Reason in ECATS for the 2020-2021 Exit Count and these students will no longer appear active in ECATS.

## 2020-2021 End of Year Data Submission for Indicator 7

All Public-School Units are responsible for certifying Indicator 7: Preschool Outcomes in ECATS. The Indicator 7 count captures the percent of preschool students with IEPs who demonstrate improved childhood outcomes and is based on data from July 1, 2020 through June 30, 2021. The Indicator 7 Count opens August 2, 2021 and is due by close of business August 20, 2021. The training video, ECATS Webinar – Indicator 7 Reporting, along with additional reference handouts are posted in each district's ECATS instance on the main page under Resources > Federal Reporting. ## 2020-2021 End of Year Data Submission for Indicator 12

Indicator 12 captures data on students who received Part C services and were referred to Part B during the July 1, 2020 through June 30, 2021 fiscal year. All students must have an IEP developed within 90 days of the referral and receive services by their 3rd birthday.
