


- **Disturbance 1** (as of 8:00 a.m. ET)

- Disturbance 2 (as of 8:00 a.m. ET)
- A few hundred miles S of the Gulf of Tehuantepec
- Tropical Depression could form late this
- 48-hour formation chance: Low (near 0%)
- 5-day formation chance: Medium (40%)





### Disturbance 1 (as of 8:00 a.m. ET)


- Located a short distance east of Jacksonville, FL











# **Precipitation & Excessive Rainfall**






# Long Range Outlooks - Jul 31-Aug 4


