


### **Tropical Outlook – Five Day**

### **Eastern Pacific**




#### Tropical Storm Marty (Advisory #1 as of 5:00 a.m. ET)

- 210 miles SSW of the southern tip of Baja California
- Maximum sustained winds 40 mph
- Moving W at 15 mph
- Slight strengthening is possible today; gradual weakening is forecast to begin on Tuesday and Marty is forecast to weaken to a tropical depression by early Wednesday
- Tropical-storm-force winds extend outward up to 70 miles from the center.

#### Disturbance 1 (as of 8:00 a.m. ET)

- Forecast to form offshore of the coast of southern Mexico early next week
- Environmental conditions favorable for gradual development; tropical depression likely to form by late this week
- Formation chance through 48 hours: Low (30%)
- Formation chance through 5 days: High (70%)

### **Atlantic**



### Tropical Depression Henri (Advisory #29 as of 11:00 p.m. ET)

- 25 miles WNW of Hartford, CT
- Maximum sustained winds 30 mph
- Moving WNW at 8 mph
- Expected to move across MA today and over the Atlantic on Tuesday.
- This is the last public advisory issued by the National Hurricane Center on Tropical Depression Henri.

### Disturbance 1 (as of 8:00 a.m. ET)

- Several hundred miles W of the Cabo Verde Islands
- Little development expected during the next couple of days
- Formation chance through 48 hours: Low (near 0%)
- Formation chance through 5 days: Low (30%)

### Disturbance 2 (as of 8:00 a.m. ET)


- Expected to form over the eastern Caribbean Sea late this week
- Environmental conditions favorable for gradual development Formation chance through 48 hours: Low (near 0%)
- Formation chance through 5 days: Low (20%)


Heaviest rainfall with Henri occurred across the NYC Metropolitan area over the weekend with most total amounts in the range of 4-7 inches from central Long Island westward across the New York City area, much of northern New Jersey and northeast Pennsylvania.

Newark: 10.46 inches Brooklyn: 9.08 inches Jameburg, NJ: 8.67 inches Central Park: 7.84 inches



As TD Henri tracks to the east today an additional rainfall of 1 to 3 inches, with locally higher amounts, will be possible through early Tuesday, especially from southeast New York across southern New England.

Given the the sensitivity in areas that have already experienced extreme rainfall over the past 1-2 days, as well as ongoing flooding, any additional tropical downpours will likely have adverse impacts. These impacts will be most likely in the Moderate Risk area today.

### **Tropical Depression Henri-Region I Response**

Situation: As of 5:00 a.m. ET, Tropical Depression Henri was located 60 miles north-northwest of New York City with maximum sustained winds of 30 mph. Henri is expected to stall near the Connecticut-New York border and move across Massachusetts today, and over the Atlantic tomorrow. Lifeline impacts are stable across all affected states. Power outages trending downward as restoration efforts are conducted. Several federal/state deployed assets will begin to deactivate and activated state EOCs are reassessing activation levels.

#### Impacts:

- 43,145 (8%) customers remain without power in Rhode Island (Eagle-I as of 7:30 a.m. ET)
- Shelters: CT: 7 open with 30 occupants; MA: 5 open with 6 occupants (Region | SLB, 8/22/21, 11:00 a.m. ET)


#### State / Local Response:

- CT, RI, & MA EOCs at Full Activation; NH, VT, & ME EOCs at Partial Activation (COVID-19)
- Mashpee Wampanoag Tribe at Full Activation; Mashantucket Pequot Tribe at Partial Activation
- RI and CT Governors declared State of Emergency
- VT Governor requested Emergency Declaration on August 22
- Shinnecock Nation of Indians declared a state of emergency
- Shelters: CT: 7 open with 30 occupants; MA: 5 open with 6 occupants (Region I SLB, 8/22/21, 11:00 a.m. ET)

### FEMA / Federal Response:

- Region I RRCC at Level I (day shift only) with all ESFs and DCO; Enhanced Watch (night shift)
  - IMAT deployed to RI; 7 LNOs deployed to each state and tribe
- USACE Type 4 Power Restoration Team (PRT) staged at Westover, MA and Republic Airport, NY
  - All major electrical providers mobilizing restoration resources from southern states.
  - Hospitals have capacity to handle potential uptick in trauma patients
- US&R
  - White Incident Support Team (IST) with Liaison (LNO) deployed to Region I RRCC (MA)
  - 2 Mission Ready Packages-Water Rescue (MRP-WR) (PA-TF1 and NJ-TF1 staged at CT State Fire Academy)
- Emergency Declaration FEMA-3563-EM-RI approved August 21; FEMA-3564-EM-CT, FEMA-3567-EM-VT, and FEMA-3566-EM-MWTM (Mashpee Wampanoag Tribe of MA) approved August 22

### **Tropical Depression Henri-Region II Response**

All RII states green (except Health & Medical (COVID-19))

Situation: As of 5:00 a.m. ET, Tropical Depression Henri was located 60 miles north-northwest of New York City with maximum sustained winds of 30 mph. Henri is expected to stall near the Connecticut-New York border and move across Massachusetts today, and over the Atlantic tomorrow. Lifeline impacts are stable across all affected states. Power outages trending downward as restoration efforts are conducted. Several federal/state deployed assets will begin to deactivate and activated state EOCs are reassessing activation levels.



## **Flooding Impacts – Tennessee**



**Situation:** Heavy rain caused catastrophic flooding and flash flooding across Tennessee beginning August 21 and continuing. The most impacted areas are in Middle Tennessee in the counties of Dickson, Hickman, Houston, and Humphreys; the city of Waverly (population 4,105) is the most impacted. 9-17 inches of rain fell within a six-hour period Saturday morning and another round of severe weather impacted the same area Saturday night.

#### Lifeline Impacts:

#### Safety & Security

- Numerous water rescues occurred and continue in Dickson, Humphrey and Hickman counties
- Evacuations occurred in Hickman and Houston counties
- 30-40 people missing (open-source media)
- Civil Air Patrol (CAP) conducting preliminary damage assessments (TEMA SITREP 1, 8/21/21, 8:00 p.m. ET)
- Damage assessments continue in Hickman and Houston counties; currently 10-20 homes with flood damage in multiple counties; several businesses sustained damage in Houston County

#### Food, Water & Shelter

- 4 Red Cross shelters open (1 in Dickson, 1 in Hickman, 2 in Humphreys) with 89 occupants (Region IV Advisory Message, Update 3, 8/22/21, 8:01 p.m. ET)
- 2 water treatment plants damaged in Humphrey County
- Waverly (Humphreys County) water treatment well plant shut down due to flooding; all operations being run through the Duck River Surface Water Plant
- Boil Water Notice for city of Waverly and Bon Aqua

#### Health & Medical

- Three Rivers Hospital without water, National Guard is assisting
- · Waverly (Humphrey County) requested medics and providers for Waverly Hospital; staff can't get to hospital
- Fatalities: 16 (+6) confirmed in Humphreys County (TEMA Flash Report #5 Flooding, 8/22/21, 4:00 p.m. ET); media reports 21 unconfirmed fatalities

#### Energy

• 3,500 customers without power statewide (as of 7:00 p.m. ET, Region IV Advisory Message, Update 3, 8/22/21, 8:01 p.m. ET)


#### **Communications**

- · Little to no cell service, wi-fi limited; companies are working on restoring service
- Request for backup 911 to Humphreys County EMS
- Houston County 911 center is still not fully operational

#### **Transportation**

- Roads closed and bridges damaged; 3 bridges washed away in Dickson County
- Power crews are working on locations they can reach but need to wait for waters to recede for other locations
- CSX railroad traffic shut down between Dickson and Waverly






