


# East Pacific Overview TROPICAL OUTLOOK






# Hurricane Ida SATELLITE LOOP







Total rainfall of 10 to 18 inches with isolated maximum totals to 24 inches possible from southeast Louisiana and southern Mississippi through Monday. Heavy rain will then spread across Middle Tennessee to Ohio Valleys thru Wed...

These rainfall amounts will likely to result in **life-threatening** flash and urban flooding. Most extreme rainfall and significant impacts are likely in High Risk area Monday through Tuesday morning. Moderate risk extends inland thru Wed.

#### Lifeline Impacts:

- Safety and Security: Search and Rescue teams staged; no shortfalls reported
- Food, Water, Shelter: Logistics support staged; no shortfalls reported
- Health and Medical: No shortfalls or limiting factors reported
- Energy: The electricity industry reports no unmet needs with pre-incident preparations
- Communications: FEMA communications assets deployed to support key resources in anticipation of Ida landfall
- Transportation: All airports open; no limiting factors or shortfalls reported. Several ports in the area are closed

#### State/Local Response:

- LA EOC at Full Activation (COVID and TC Ida); Governor declared State of Emergency; activated 2,500 National Guard personnel
- TX EOC at Partial Activation (COVID-19 and TC Ida)
- OK EOC Partial Activation (in anticipation of request from LA for support)
- MS EOC at Partial Activation (COVID-19 and TC Ida); Governor activated 2,500 National Guard
- AL EOC at Normal Operations, Governor declared a state of emergency on Aug 28 and requested a FEMA LNO; 100 National Guard personnel activated
- FL EOC at Normal Operations


<u>Situation</u>: The Caldor Fire continues to grow. Steep and rugged terrain, critically dry fuel conditions, and lack of adequate resources have presented control challenges. Firefighters are continuing with the firing operations to strengthen control lines, but fire conditions remain active.

#### Impacts:

- Substantial critical utility infrastructure damage and destruction in the Grizzly Flats area
- PG&E distribution/transmission lines, distribution substations, telecom towers, and fiber optic resources threatened
  - Provides power to thousands of customers in El Dorado/surrounding areas; value of assets estimated to be \$11M
  - Approximately 3k (2.5% of county) customers currently without power (DOE Eagle-I, 6:45 a.m. ET, Aug 28)
- Grizzly Flats water storage/distribution infrastructure threatened; 1.2k customers potentially impacted
- HWY 50 is closed from Sly Park to the Hwy 50/Hwy 89 junction; HWY 50 is a major Trans-Sierra HWY vital to emergency evacuation (Region IX Daily Wildfire 209 Summary, Aug 27)
- USDA Forest Service, Pacific Southwest Region, closed 9 national forests through Sep 6

#### Response:

- Total personnel assigned: 3,302 (ICS-209 as of 9:00 a.m. ET, Aug 28)
- 60% of perimeter inspected; damage inspections in progress (ICS-209, 9:00 p.m. ET, Aug 27)
- Anticipated containment date: September 8 (ICS-209 as of 9:00 p.m. ET, Aug 27)
- Firefighting air tankers throughout state are flying suppression missions
- = 21 (+6) shelters / 492 (-23) occupants statewide due to wildfires (ARC Midnight Shelter Count, 7:07 a.m. ET)
- Region IX IMAT-2 and LNO deployed to CA EOC in Sacramento


