UPDATE: Program Compliance Cohort

As highlighted in the few ECD Weekly Updates, the EC Division will be coordinating a Program Compliance Cohort for members of local EC Leadership Teams tasked with supporting the EC Director/Coordinator with the supervision of local EC programs.

Recommendations were accepted through 5:00p on Friday, September 3rd. This week, participants will be provided additional information (virtual links, etc.) via the email provided when the individual was recommended.

The ECD has received a few questions regarding feedback loops and the differences between this cohort and NDLI/CECLI.

- 1. NDLI/CECLI is designed to support new EC Directors/Coordinators with supervising local EC programs systemwide and building capacity for future EC Directors/Coordinators.
- 2. The Program Compliance Cohort is designed to provide the details necessary to support the EC Director/Coordinator with the implementation and monitoring of specific services and supports within the overall local, systemwide EC Program.
- 3. A core component of the Program Compliance Cohort is a strong feedback loop with the EC Director/Coordinator that recommended participation. One key expectation is that all participants return to the district and redeliver/share the content with the local EC Leadership Team. Time will be devoted to the beginning and ending of each cohort session to identify key content for redelivery and clarify any questions from any content previously shared. It is hoped that this fosters a feedback loop locally that strengthens an entire leadership team.

4. EC Directors/Coordinators should prioritize their own participation in NDLI/CECLI as a first engagement with an EC Division cohort as it provides the big picture for leading EC programs.

Social Studies Extended Content Standards Public Comment

Alternate academic achievement standards set an expectation of performance that differs in complexity from a grade-level achievement standard. ESSA permits states to develop alternate academic achievement standards for students with significant cognitive disabilities. In North Carolina, these alternate academic achievement standards are known as the Extended Content Standards. The North Carolina Department of Public Instruction, Exceptional Children Division convened stakeholder groups to create and review proposed extended content standards for Social Studies for students with significant cognitive disabilities. The Extended Content Standards for Social Studies are open for public comment from September 8 to October 8, 2021.

Federal Reporting

Exit Count

September captures end-of-year reporting data on students exiting special education during the July 1, 2020 through June 30, 2021 fiscal year. The Exit Count opens September 15, 2021 and is due by close of business September 30, 2021.

• 2020-2021 End of Year Data Submission for Indicator 12

Indicator 12 captures data on students who received Part C services and were referred to Part B during the July 1, 2020 through June 30, 2021 fiscal year. All students must have an IEP developed within 90 days of the referral and receive services by their 3rd birthday. Indicator 12 will be submitted on spreadsheets by all PSUs and can be accessed by clicking this link: Indicator 12 Spreadsheet or by going to the ECATS site under Resources (https://www.dpi.nc.gov/districts-schools/classroom-resources/exceptional-children/every-child-

<u>accountability-tracking-system-ecats/resources</u>). The spreadsheet has a tab with helpful clarifications to assist PSUs on entering their data and can be submitted at any time prior to the due date of October 29, 2021. Charter Schools do not need to submit an Indicator 12 spreadsheet this year. Please email all Indicator 12 spreadsheets to <u>ecindicators@dpi.nc.gov</u>.

Indicator 8 Reminder

For the select districts who have been notified, please be sure to get the Indicator 8 surveys out to the parents.

• Important Federal Reporting Reminder: Submission Timeliness

If your district does not certify the data required for Indicators by the due date, your data may be certified by state staff. The integrity of the data is always at risk when the Department of Public Instruction has to finalize the data for your district. There will be penalties when data is not submitted in a timely manner.

House Bill 1030 Consent for Release of Information to the Residential Schools for the Deaf and Blind

The electronic reporting link is now available for the HB 1030 Release of Information to the Residential Schools for the Deaf and Blind. The survey may be accessed at the hyperlink above as well as under the Forms tab on the Federal Regulations & State Policies page on the EC Division website.

As a reminder, PSUs **must** provide a consent of release of information form to receive more information about the NC schools for the deaf and blind to parents of students identified as Deaf, Hearing Impaired, Visually Impaired, Deaf-blind, or Multiply Disabled with a vision and/or hearing loss. This consent form **must** be sent to parents by October 1 of each school year. By November 30 of each school year, all PSUs, including charter schools, **must** use the electronic reporting tool to report one of the following:

- No parents in the PSU provided consent; OR
- · Which parents provided a YES consent.

Read to Achieve Memo

The State Board of Education has approved a list of alternate assessments that can be used as an alternate demonstration of proficiency. The memo includes this list and processes that must be in place to use in alternate assessment. For most students with disabilities, mclass DIBELS 8 or an approved alternate assessment will be accessible to the student. In rare situations, an Individualized Education Program (IEP) team may determine that a student with a significant disability is unable to access mClass DIBELS 8 or any of

the assessments on the SBE approved list. In such situations, the student's literacy skills shall be assessed with a validated measure of early reading that is accessible to the student. Selection of these assessments should be determined by the Public School Unit in consultation with local Exceptional Children staff. Validated assessments do *not* need to be purchased assessments, but validated indicators of literacy/pre-literacy skills that are teacher constructed (e.g., eye gaze to a letter on a card containing multiple letters when orally presented the letter sound). Child Count

The December Child Count is calculated via active IEPs in ECATS that are in place on December 1. Students with a lapsed eligibility will be included <u>if</u> there is active IEP in place (e.g., in situations when the IEP date extends beyond the lapsed eligibility date). If both the eligibility and the IEP lapse, the student cannot be included in the count (this is consistent with OSEP calculation requirements). Please note, an IEP can't be finalized in ECATS and become active if there is a lapsed eligibility.
