

Recycling Modernization Act

Stakeholder Engagement Opportunities

The Plastic Pollution and Recycling Modernization Act is effective on Jan. 1, 2022. Recycling program changes will begin in July 2025. The start-up phase will span multiple years with extensive planning, research, rulemaking and stakeholder engagement. DEQ will keep interested stakeholders informed and seek input through several different channels throughout that time.

There are several opportunities for interested stakeholders to provide input, both during the start-up phase and ongoing into program implementation:

- Rulemaking public comment periods 2023 and 2024
- Producer Responsibility Organization (PRO) program plan reviews March 2024 and upon amendment
- PRO annual report reviews Ongoing annually

Governor-appointed committees

Truth in Labeling Task Force

The Truth in Labeling Task Force consists of 13 members appointed by the Governor, and two non-voting members of the Legislature. The task force will study and evaluate misleading or confusing claims regarding the recyclability of products made on a product or product packaging. The Task Force will meet between January and June 2022, and submit a report to the Oregon Legislature by June 1, 2022. The task force will elect a chairperson and will meet at times and places specified by the chairperson or a majority of voting members of the task force. The public can attend task force meetings.

Oregon Recycling System Advisory Council

The ORSAC consists of 17 members appointed by the Governor, and two non-voting members of the Legislature. The council will advise DEQ and the PROs on key system elements, including the uniform statewide collection list, PRO program plans, and more. The ORSAC will meet at least once every three months, and terms are three years in length. The public can attend council meetings.
