# Winter Storms – Southern Plains

<u>Situation</u>: Over 7.5M (-0.1 M) people across Texas are currently under boil water notices. Personnel and resources are staged to support ongoing state requests for assistance.


Food, Water, and Shelter:

#### Shelters:

- TX: Non-ARC congregate shelters open: 1 with no (-2) occupants (*DR*-4586-TX Winter Weather SLB 12:00 p.m. ET, Feb 24); ARC shelters open: 1 with 80 occupants (*ARC Midnight Shelter Count, 7:01 a.m. ET, Feb 24*)
- OK: 3 shelters open with 51 (+1) occupants (ARC Midnight Shelter Count, 7:09 a.m. ET, Feb 24) Water:
- TX: 1,334 (-1) Boil Water Advisories affecting 7.5M; 7 (+3) wastewater systems are non-operational, 4 wastewater treatment plants are non-operational (DR-4586-TX Winter Weather SLB 12:00 p.m. ET, Feb 24) Health and Medical:
- Injuries/Fatalities:
  - TX: 107 injuries and (23 +14) confirmed fatalities (DR-4586-TX Winter Weather SLB 12:00 p.m. ET, Feb 24)
  - LA: 3 fatalities (confirmed)

#### State / Local Response:

- LA EOC at Partial Activation (COVID, TC Laura, Zeta, Delta, & winter weather), National Guard activated
- OK EOC at Partial Activation (COVID & winter weather); Governor declared a State of Emergency
- TX EOC at Partial Activation (COVID & winter weather), 24/7; Governor declared a State of Emergency, National Guard activated






## Winter Storms – Southern Plains

#### FEMA / Federal Response:

- Major Disaster Declaration FEMA-4587-DR-OK approved Feb 24
- Major Disaster Declaration FEMA-4586-DR-TX approved Feb 19
- Region VI RRCC at Level I, 24/7 (Winter Storms); IMAT-1 deployed to NM & OK (COVID); IMAT-2 deployed to TX (COVID)
- National IMAT-RED deployed to TX
- USACE Type 3 Power Restoration Team and 2 Subject Matter Experts (SME) staged in DFW
- MERS deployed to Austin, TX
- FEMA Logistics
  - Logistics Staging Management Team (SMT) and Logistics Incident Support Base (ISB) Bravo Team Federal Staging Area (FSA) Seguin, TX; ISB Dallas is operational
- HHS declared a Public Health Emergency for TX due to winter weather
- NRCC at Level I (COVID); NWC is monitoring






## **COVID-19 Vaccination Sites Closures**

#### Situation:


The National Watch Center, in coordination with all ten Regional Watches, is monitoring for potential impacts to COVID-19 vaccination sites

- 63 Federally Supported Community Vaccination Centers closed.








