- Intentionally failing to disclose that the funds invested in the Program would be used for purposes other than the purchase of investment vehicles, such as equities, bonds, ETFs, mutual funds, and options, a material fact; and or

- Intentionally failing to disclose that previous investors funds were used to pay distributions to other investors, a material fact; and or
- Intentionally failing to disclose that the profit and principal payments made to investors were not generated from revenue and profits earned, but instead, paid with funds received from other investors, a material fact; and or
- Intentionally failing to disclose that funds invested by previous investors were commingled with those of other investors and, with the Defendant's personal accounts, a material fact; and or
- Intentionally failing to disclose that funds paid by previous investors were used to pay the Defendant's personal expenses and the personal expenses of the Defendant's family, a material fact; and or
- Intentionally failing to disclose that the Program was not earning sufficient profits to pay interest owed to investors, a material fact; and or
- \* Knowingly and intentionally representing that the Program was generating sufficient profit from the buying and selling of securities to meet the monthly interest payments represented in the investors notes in the Program, a misrepresentation of a relevant fact; and or
- Knowingly and intentionally representing that Defendant was paying interest payments to investors based on Program profits, a misrepresentation of a relevant fact; and or
- Knowingly and intentionally representing that the Defendant would not receive compensation unless the Program earned 5% returns per month and, thereafter, the Defendant would only be compensated the excess income above 5% for services in connection with said offering, a misrepresentation of a relevant fact; and or
- Knowingly and intentionally representing that Defendant would invest funds as per the regulations set forth by the United States Securities and Exchange Commission, a misrepresentation of a relevant fact, and or
- Intentionally failing to disclose that the Defendant was not registered with any securities regulatory agency and that the Defendant did not follow regulations set forth by the United States Securities and Exchange Commission to claim an exemption from registration, a material fact; and or

Intentionally failing to disclose that neither the Defendant, the Program, nor any of its employees, were registered to sell securities or render investment advice, a material fact; and the aggregate value of the amount involved was \$100,000.00 or more;
