I N F O R M A T I O N

The defendant having waived in open court prosecution by indictment,  
the Acting United States Attorney for the District of New Jersey charges:

**(Possession of Child Pornography)**

On or about November 13, 2020, in Ocean County, in the District of New  
Jersey, and elsewhere, the defendant,

ANDREW RAMEY,

did knowingly possess material that contained at least 600 images of child  
pornography, as defined in Title 18, United States Code, Section 2256(8), which  
involved a prepubescent minor and a minor who had not attained 12 years of  
age, and which had been mailed, or shipped or transported using any means or  
facility of interstate or foreign commerce or in or affecting interstate or foreign  
commerce by any means, including by computer, or that was produced using  
materials that had been mailed, or shipped or transported in or affecting  
interstate or foreign commerce by any means, including by computer, after  
having previously been convicted, in the United States District Court for the  
District of New Jersey, of possession of child pornography in violation of Title  
18, United States Code, Section 2252A(a)(5)(B).

In violation of Title 18, United States Code, Sections 2252A(a)(5)(B) and 2252A(b)(2).

FORFEITURE ALLEGATION

1. The allegations above and on page 1 of this Information hereby are realleged and incorporated by reference for the purpose of alleging forfeiture pursuant to Title 18, United States Code, Section 2253(a).

2. Upon conviction of the violation of Title 18, United States Code, Section 2252A(a)(5)(B) charged in this Information, the defendant,

ANDREW RAMEY,

shall forfeit to the United States, pursuant to Title 18, United States Code, Section 2253,

- a. any visual depiction described in 18 U.S.C. §§ 2251, 2251A, 2252, 2252A, 2252B, or 2260, or any book, magazine, periodical, film, videotape, or other matter which contains any such visual depiction, which was produced, transported, mailed, shipped or received in violation of 18 U.S.C. Part I, Chapter 110;
- b. any property, real or personal, constituting or traceable to gross profits or other proceeds obtained from the offense charged in this Information, and all property traceable to such property; and
- c. any property, real or personal, used or intended to be used to commit or to promote the commission of such offense, and all property traceable to such property.

3. The property to be forfeited includes, but is not limited to, all of the defendant's right, title, and interest in the following items:

4. If any of the property described above, as a result of any act or omission of the defendant:
- a. cannot be located upon the exercise of due diligence;
  - b. has been transferred or sold to, or deposited with, a third party;
  - c. has been placed beyond the jurisdiction of the court;
  - d. has been substantially diminished in value; or
  - e. has been commingled with other property which cannot be divided without difficulty,
- the United States of America shall be entitled to forfeiture of substitute property pursuant to Title 21, United States Code, Section 853(p), as incorporated by Title 18, United States Code, Section 2253(b) and by Title 28, United States Code, Section 2461(c).
