<u>Psychological and counseling evaluation services:</u>

<u>Division of Health Benefits (DHB) LEA Policy 10-C</u> was updated on February 1, 2022, to expand the list of practitioners considered qualified by Medicaid/DHB to be reimbursed for psychological and counseling evaluation services.

Section 6.0 *Provider(s) Eligible to Bill for the Procedure, Product, or Service* (page 20) now reads that all providers of psychological and counseling services "shall provide documentation of appropriate training and experience, which qualifies them to work with students in an educational setting. All providers shall function within the scope of practice of their state license and certification."

Charter Schools enrolling as Medicaid Providers, pursuant to SL-2021-180.105 9D.21:

On Feb. 3, 2022, <u>DHB posted a bulletin outlining enrollment requirements</u> to begin participation in the LEA reimbursement program. This bulletin should be read carefully to understand DHB requirements and ensure efficient procedures for Charters who participate in Medicaid reimbursement programs. Courtesy Alert: Homebound/Hospital Attendance Code for 2022-2023

The Exceptional Children Division and Home Base team have partnered to create a Homebound/Hospital attendance code (1S) for use in PowerSchool for the 2022-2023 School Year and going forward. This code is to be used for "Homebound/Hospital" or "Homebound Instruction" which are terms used interchangeably to describe *educational services* that are provided

outside of school must be documented in a written homebound plan, a Section 504 Plan, or Individualized Education Program (IEP).

In preparation for the roll-out of this attendance code, the following activities and timelines are proposed:

- February 2022 Courtesy Alert to PSUs
- Spring 2022 Technical Assistance Webinars/Resources/Implementation Guide
- July 2022 Homebound/Hospital Attendance Code live in PowerSchool
- Fall 2022 Update included in Student Attendance and Student Accounting Manual

Technical assistance will include examples of how to appropriately document the specifics of the educational services to be provided based on whether the student is disabled (IEP/504 Plan) or nondisabled. Differences between this code (1S) and existing codes with examples of appropriate use cases will be provided.

Special grants, with the status of Chief Administrator Approved, are reviewed monthly after the 15th. (If the 15th falls on a weekend or holiday, the review will start of the next business day after the 15th). Notification of

• IDEA/ American Rescue Plan Act of 2021 (ARP)

American Rescue Plan budgets should be submitted as soon as possible.

The American Rescue Plan funds have been allotted under the following Program Report Codes. The budgets will be submitted the same way as the IDEA budgets. A new application is not required.

PRC 185 and PRC 186 Budgets and Allotments

At the current time, those with approved budgets for PRC 185 and PRC 186 have been allotted 75% of their total funds. The additional 25% will be included in a futures allotment. PSUs do not need to make a change in the approved budget. When the additional 25% is allotted, the budget will be reviewed for alignment with the final allotment. Funds.
