QRIS (Quality Rating Improvement System) officially relaunched on June 1st. We have had over 2,350 programs apply! As a reminder to be eligible for the Lakeshore and financial incentives you must complete the **Stars Request for Certification** prior to **November 30, 2022**.

We are encouraging **EVERY** provider in Oklahoma to apply! By participating in QRIS, providers embark on a path of continuous quality improvement that benefits both the children they serve and their business practices. Even providers that have met the standards of the lowest STAR levels have achieved a level of quality that is beyond the minimum license requirements to operate. Every child deserves a quality early childhood education experience!

The Stabilization Grant

WHAT: Cycle 6 Stabilization Grant WHEN: Closed October 31, 2022 WHY: Quality & Stabilization Support WHO: ALL PROVIDERS!



Additional Information

Cycle 6 offered a double payment amount + an additional 5% to help pay for 5 year fingerprint rechecks. Not only will this provide continued stabilization support, it will promote quality programming for Oklahoma children.

The Workforce Support Grant

- WHAT: Cycle 2 Bonus Payment for Child Care Staff
- WHEN: Closed October 31, 2022
- WHY: Child Care Staff Retention & Recruitment Support
- WHO: Child care employees working in a permitted or licensed program

Additional Information

This grant will be open for four cycles so programs are able to include all staff working in their facility. **Please remember that staff only qualify** for one **\$1,000 bonus**.

All staff MUST have a registry ID to receive the bonus payment. OKDHS will be working with the CECPD to make sure payments go directly to the child care staff. All the required qualifications and information will be listed on the OKDHS grants website.

CECPD will email easy-to-follow instructions to each Child Care Center and FCCH that qualifies for the Workforce Support Grant incentive to collect additional information on your staff. Please follow the instructions that will be included in the email. This is a 2-step process, programs must also complete the workforce grant application.

Exceptional Needs Grants



WHAT: Exceptional Needs Grants

WHEN: Launched August 10, 2022 - open through July 2024 (or when funds deplete) WHY: Promote the economic and social well-being of special needs children and families

WHO: For providers who currently serve or are looking to expand and serve exceptional needs children.

Additional Information

The exceptional needs grant is specifically designed for providers who are looking to expand their services to be able to serve exceptional needs children, as well as for providers who currently serve this population who are looking to expand their programs.

It will consist of a single facility application and an open window to submit proposals for approval. Once approved and purchases are made, they will be able to upload receipts to their approved plans in order to seek reimbursement.

Child Care Desert Grants



WHAT: Desert Grants
WHEN: Launched August 10, 2022 - open through July 2023 (or when funds deplete)
WHY: Increase accessibility to quality child care in identified child care desert counties.
WHO: New programs and existing programs in identified desert counties.

Additional Information

There are two options:

 New programs wishing to start a CCC or FCCH/LFCCH in desert areas or
 Existing programs currently serving children that would like to expand their capacity in the identified counties.

An example of this would be a FCCH provider that meets LFCCH qualifications or a child care center that has the space to increase their capacity. Per federal guidelines, funding may not be used for purchase of land, structures or major renovations.

Subsidy Spotlight Special Needs Unit Type

Unit Type approved for a child with disabilities is in addition to the rate received for a typical child of the same age. To be authorized at this higher rate, the special needs process must be followed.

You, the provider, will initiate the special needs rate process by accessing the Special Needs Rate Request form, located on the Child Care Subsidy Handbook, Section T: Child Care Handbook (<u>https://childcarehandbook.oucpm.org/section-t</u>).

You, the client, and your licensing specialist must then complete the appropriate sections of the form. This form helps determine any extra care the child may require from you, how these care needs will be met, whether you meet certification requirements to receive the rate and what rate is approved.
