THE STARS PROGRAM



We want to ensure all programs are successful. Therefore, the Star monitoring reviews throughout 2023 will be discussion visits only! Criteria violations will not be documented. This will allow you time to learn and properly implement the Stars criteria. Full monitoring is expected to resume in January 2024.

However, the last 24 months of licensing monitoring will continue to be reviewed and numerous, repeated or serious non-compliances with minimum licensing requirements will be documented and may result in stars reduction.

You can submit a request for a higher Star level at any time!

The Quality & Stabilization Grant

WHAT: Cycles 7 - 9 Quality & Stabilization Grant WHEN: Cycle 8 opens April 1st and closes April 30

WHY: Quality & Stabilization Support

WHO: ALL PROVIDERS!

New Star Level % Increase
One Star 0%
Two Star 100%
Three Star 125%
Four Star 150%
Five Star 175%

Remember: Staff only qualify for one \$1,000

bonus in total!

Additional Information

Cycles 7-9 offers a doubled payment amount and an **additional percentage increase** based on the program's new star rating on January 1, 2023.

Examples:

- A Five Star Home with a capacity of 7 will receive the doubled base amount of \$6,000 + 175% increase = \$16,500.
- A Five Star Center with a capacity of 50 will receive the doubled base amount of \$22,000 + 175% increase = \$60,500.

The Workforce Support Grant

WHAT: Cycle 3 Bonus Payment for Child Care Staff WHEN: Cycle 4 opens April 1, 2023 (Last Cycle)

WHY: Child Care Staff Retention & Recruitment Support

WHO: Child care employees working in a permitted or licensed program

Home Address in the Registry Must be Current!

Workforce debit cards are mailed to the HOME ADDRESS the participant has listed in their Oklahoma Registry individual account. Participants can update their HOME ADDRESS by logging into their Registry account and updating their Personal Information. If there is a statement in their account that says, READ ONLY, they should complete https://bit.ly/CECPDParticipantUpdateForm and email to cecpd@ou.edu.

SCHOLARSHIP OPPORTUNITY



UPDATED: In January 2023 the Scholars for Excellence in Child Care scholarship began providing 50 scholarships for assistant directors or directors of licensed child care facilities to apply for the National Administrators Credential (NAC) administered by NECPA.

The scholarship will cover 100% of the 40 clock hour online course for the NAC credential (\$620) and upon attainment a \$200 stipend to the child care staff member.

OBI – Federal Child Care Qualified Entity Audit

The Office of Background Investigations (OBI) continues to conduct the bi-annual Qualified Entity (QE) audit survey for all General Administrative Offices (GAO), Temporary Hiring Authorities (THA), and child care programs.

The QE audit survey is an educational process to ensure understanding of the federal laws for the storage, handling, and dissemination of fingerprint-based criminal history results. Completion of the QE audit survey is required to maintain a valid QE.

The QE audit survey will soon end for Family Child Care Home programs. Audits surveys are sent by email to the Authorized Recipient; or US Mail, if requested. If you received a survey but have not yet completed it, please locate the survey form, fill it out, and return it to OBI, ASAP. If OBI does not received your completed survey, your QE status will be terminated.

Termination of your QE status means that your program will no longer be able to receive background check results for your employees, which could affect your compliance with licensing requirements.

The next cycle of the audit surveys will involve GAOs and THAs, followed by Residential and Child Placing Agency programs. Child Care Center based programs will be the final group to participate in the audit survey process, later this year.

All programs should anticipate the receipt of the audit survey and plan to complete it.

Remember, an updated Qualified Entity Application and Agreement (19LC112E) form is required when there is a change in an Owner/Responsible Entity, the Authorized Recipient, adding or removing programs for GAOS; and any contact information: address, phone number, email addresses.

New Grant Payment Information

The OKDHS Finance Department is working to move all providers to a new payment system. Providers who have received grant fund payments recently received the below email. The form referenced can be found in the email.

OKDHS is in the process of moving payment systems. In order to receive your next grant disbursement, please provide your updated information on the attached form as soon as possible. You will need to fill out one form for each child care facility that you operate.

Payment Information Form

In order to complete the form, you will need to have access to the following:

- Taxpayer Identification Number
- W9*
- Certificate of Good Standing (does not apply to individuals or sole proprietorships)
- Banking verification (must be one of the following)
 - Bank Signed OMES EFT Direct Deposit Enrollment Form
 - Bank Issued ACH Direct Deposit Verification Letter
 - Bank Issued ACH Direct Deposit Authorization Form (Individuals, Sole Proprietors, and Single Member LLCs Only. This can be found on your bank's website.)


FILL YOUR OPEN POSITIONS THROUGH SHARED SERVICES!

Before a contract request can be submitted for evaluation, providers must have an approved license or permit from Oklahoma Human Services.

Step #2

Begin the Stars Program

Providers must be participating in the Stars program. The Stars level that must be obtained before you may submit a request for a contract is shown below:

Child Care Centers:

• Must be a 2 Star program or higher.

Child Care Homes:

- If licensed, must be a 1 Star program or higher; or
- If permitted, must be a 2 Star program or higher.
