Powerschool Preschool Course Codes

NCDPI and PSU staff have a professional obligation to ensure that preschool data is current, valid, and reliable to best support and advocate for our state preschool/prekindergarten programs. This will require consistency in the way we create student records in the Student Information System, PowerSchool.

To support consistency in the data, DPI has created two new course codes for preschool, 99329P0 - Activity Period/Home Room and 99359P0 - Pre-K Classroom.

Beginning in the 2023-2024 school year, each preschool/pre-kindergarten teacher should be assigned a Home Room course code (99329PO - Activity Period/Home Room) and their students should be enrolled in their teacher's Home Room course code section.

The new non-reporting course code (99359P0 - Pre-K Classroom) should be used for scheduling Specials (ex. Music, Art, PE, etc.).
