EDDIE

The Educational Directory and Demographical Information Exchange (EDDIE) is an online application containing LEA (school district) and school information such as LEA numbers, school numbers, select administrative contacts, addresses, grade levels, calendar types, and more. EDDIE does not contain individual teacher or student information.

EDDIE is the authoritative source for NC public school numbers and demographic information, and is used by multiple systems/NCDPI offices, including the Office of Exceptional Children, for identifying the local point of contact for EC programs and local leadership. The OEC will be utilizing EDDIE to ensure its formal letters and email communication is addressed to the appropriate local personnel. Previously, the OEC maintained separate lists of this information. However, this process is duplicative and may not always reflect current staff or the appropriate EC administrative designee.

Please make sure that EDDIE is up to date per the NCDPI website directions and April 2023 Memorandum from the Division of School Business. **The OEC will migrate fully to using EDDIE as its authoritative source for the distribution of the September 6, 2023, Weekly Update and all other OEC communication thereafter.** When viewing EDDIE, the OEC will be retrieving the names of the individuals listed as the contact for "Exceptional Children", "Superintendent" and/or "Director Charter School" as appropriate.
