Allison owns Manic Monkee, which is a firm that does artist development, strategic business development, creative engaging activations for all kinds of brands, produces and talent buys for festivals/events and aligns brands and artists with sponsorship/partnerships. Allison is also on the Board of Directors for Non-Profit music charities Sweet Relief and Charity Bomb. She also produced LA's first all solar powered music festival Sunstock Solar Festival, where all the proceeds went to children with cancer. Allie is the head of partnerships for Muzooka that manages digital

artist assets for festivals/ticketing/DSP's/artists/charts and has streamlined set list reporting and helping rights holders get paid when their songs are performed live. Allie is a frequent speaker at international events.



Andrea DaSilva serves as the Global Team Leader for Media & Entertainment Industries and Senior Trade Policy Analyst at the U.S. Department of Commerce. In this capacity she leads a team of 260 trade specialists world-wide on projects to advance the export and licensing potential of the U.S. creative and innovation economy. Worldhaus is an international music company that offers artist management, music publishing, media content aggregation, international

cultural exchanges, industry liaison with the U.S., Brazil and UK, career coaching, songwriting and song catalog management. Myla lived in Brazil for 8 years and continues to be active with an office in Porto Alegre and participating on the SIM São Paulo conference Council Board.

Neeta Ragoowansi is an entertainment attorney and President of the Music Managers Forum-US, the trade association for artist managers and self-managed artists.
