# REOPENING OREGON OLCC GUIDANCE — PHASE ONE



### **ON-SITE SERVICE AND CONSUMPTION**

#### **REOPENING (PHASE I)**

Governor Kate Brown announced that businesses in counties satisfying specific public health requirements are eligible to reopen. The Governor's plan announced three phases. Many counties were approved to reopen under Phase I as early as May 15, 2020.

- Also visit <u>OHA's Reopening Guidance Tool</u> to determine what OHA guidance applies to your business and what is allowed under the Governor's executive orders, based on the Phase the county is in.

Once a county is approved to reopen, the restaurants, bars, breweries, brewpubs, wineries, tasting rooms, and distilleries in that county may begin limited reopening. Licensees in counties in Phase I must comply with specific Oregon Health Authority (OHA) Phase I reopening guidance.

## MY OLCC-LICENSED BUSINESS IS IN A COUNTY APPROVED TO REOPEN (PHASE I). ARE THERE ANY OLCC REQUIREMENTS?

Licensees in counties approved to reopen may begin operating without notifying the OLCC, as long as no changes are made to the premises, and licensees comply with OHA social distancing requirements.

### EXPANDING THE AREA WHERE YOU WANT TO SELL AND SERVE ALCOHOLIC BEVERAGES FOR ON OR OFF-PREMISES CONSUMPTION

Licensees in counties approved to reopen that are expanding their alcohol service areas to comply with OHA social distancing requirements **MAY** need to notify the OLCC of the expansion prior to starting operations in the new area.

#### On-going (permanent) expansion of premises

If the licensee is expanding to an **outdoor area for more than 180 consecutive days or to an indoor area**, the licensee **MUST** submit an application to the OLCC. Go <u>here</u> for an application to expand a service area.

#### <u>Limited duration or intermittent expansion of premises</u>

If the licensee is expanding to an **outdoor area** and the landowner (publicly or privately owned) granted permission for use of the area as a part of the business **on a limited basis** (not all days of the week or 180 days or less), licensees **must read and follow:** 

- OAR 845-005-0329(3) and OAR 845-006-0309 if the outdoor area is not continuous with your current premises, or
- OAR 845-005-0331(3) if the area *is* continuous with your current premises.

If you meet all the requirements in the rule that applies to the outdoor area you are proposing to use as a part of your licensed premises, YOU DO NOT NEED TO SUBMIT THE APPLICATION TO EXPAND THE SERVICE AREA.

#### **GUIDANCE ON IMPORTANT OLCC TOPICS:**

#### **CURRENT OLCC LICENSE**

Only businesses with a **current** OLCC license may sell and serve alcoholic beverages for drinking on or off of the premises.

If you **do NOT have a current OLCC license** and you want to sell and serve alcoholic beverages for drinking on or off of the premises, you must apply to the OLCC for a license. Go <u>here</u>.

#### LIQUOR LIABILITY INSURANCE

If you have a license with a liquor liability insurance requirement, you **must** have current liquor liability insurance for the premises that meets minimum coverage requirements **prior to** re-starting the sale or service of alcoholic beverages for on-premises consumption.

If you provided notice to the OLCC that you cancelled or suspended your liquor liability insurance policy because of COVID-19 business conditions, please follow the process outlined in this document before re- starting the sale or service of alcoholic beverages for on-premises consumption.

#### **OLCC MINOR POSTINGS**

Licensees who do not want to allow minor patrons into a premises, room, or area where minors already are prohibited under the minor posting assigned by the OLCC, do not need to contact the OLCC on this issue.

Licensees who want to allow minor patrons into a premises, room, or area where minors are already prohibited under a minor posting assigned by the OLCC, may allow minors into the room or area provided they:

- **DO NOT** allow minors in a room or area where there are video lottery games (but not other games offered by the Oregon Lottery, such as scratch-its, keno, etc.) or nude entertainment and not allow minors in an area where this entertainment is visible.
- **DO** ensure that in the premises, room, or area where minors are allowed that either:
  - The primary activity is patrons consuming food; or
  - If the primary activity is not solely patrons consuming food, there is not a combination of conditions or factors which create an environment where drinking alcohol is or appears to be the predominant activity. Typically, this scenario is created by the <u>combination</u> of several factors, such as dim lighting and the conspicuous display of multiple alcohol signs, banners, and posters.

#### OTHER IMPORTANT OLCC INFORMATION
