Code Ann. 5-27-602(a)(2) Classification C Felony-20 Counts in the County of Saline, State of Arkansas, you are commanded forthwith to arrest said individual and bring him/her before the Judge of this court to be dealt with according to law, or admitted to Bail as specified below.

ARREST AFFIDAVIT

Comes now Special Agent Walter Mahone of the Arkansas Attorney General's Office, on oath swear and affirm that to the best of my knowledge and belief, the following facts and evidence exist to believe that David Jefferson Brown, White/Male, D/O/B: 06/02/1975, ARKANSAS D.L. 932297234, L.K.A. 912 Fox Ridge Dr., Benton, AR 72019 has violated the laws of the State of Arkansas being: Distributing, possessing, or viewing of matter depicting sexually explicit conduct involving a child, Ark. Code Ann. 5-27-602(a)(2) Classification C Felony- 20 Counts

Statement of Facts and Circumstances:

During authorized internet undercover operations, Special Agent Michael Hendrix with the Arkansas Attorney General's Office-Special Investigations Department identified a computer reportedly in Arkansas, at IP address 170.10.43.93 that was offering to participate in the distribution of known child sexual exploitation material.

Between 11/06/2019 and 01/01/2020 SA Hendrix established direct connections with a computer at IP address 170.10.43.93 and successfully obtained partial and completed downloads of files containing child sexual exploitation material, that a computer at IP address 170.10.43.93 was making publicly available. There were 70 files downloaded, but the following is a summary description of some of the files:

- File Name: (Pthc) Tara Toca Piano-9 or 10yo Girl-Real orgasm!!! EXCELLENT=Visto-MAP-(1)
- This video file depicts one (1) prepubescent female child approximately 8-10 years old that is completely nude, sitting on a chair. The camera is resting in front of the child, stationary. The female child is wearing a purple mask with feathers that is completely covering her face. The female child is inserting a penis shaped sex toy into her vagina repeatedly. At 00:52 seconds into the video, the video freezes and begins playing again at 02:09. Once the video begins playing again, the camera is being held by an unknown person, close to the female child's vagina. The female child is still penetrating her vagina with the sex toy. At 02:24, the unknown camera man says, "Pull it out," and the female child removes the pink sex toy from her vagina. The camera then turns off at 02:31 and begins again at 02:33, back in the original place the camera was set up. The female child is now masturbating using her fingers. The video freezes at 02:48 and begins playing again at 03:27. The child continues to masturbate until the video ends.
- I, Special Agent Walter Mahone, viewed this file and found it to be an approximately 4 minute child sexual abuse video. In my training and experience, this video is child exploitation material.

- File Name: Tara 8 Years Old Ass Fuck And Ass Vibrator! New! 2007 (Kleuterkutje) (Pedo) (Kingpass) (Valya) (Pthc)
- This video file depicts one (1) prepubescent female child approximately 8-10 years old and (1) adult male on a bed. When the video begins, there is music playing and the female child is on top of the adult male. The camera is stationary, showing the back of the child. The adult male is on his back and is inserting his penis into the vagina of the female child. The female child remains on top of the adult male for approximately one minute and 30 seconds. At 01:36, the camera turns off and beings filming again, one second later. The female child is then shown on her hands and knees while the camera remains stationary. The adult male is on his knees to the left of the female child and is inserting a white, penis shaped sex toy into the anus of the female child. The adult male penetrates the female child's anus until the camera is shut off. A blue screen then appears and a text box appears that states, "filmed February 7th, 2007," and another text box states, "music by Vanity 6."
- I, Special Agent Walter Mahone, viewed this file and found it to be an approximately 3 minute and 20 second child sexual abuse video. In my training and experience, this video is child exploitation material.
 - File Name: ! New! (Pthc) 2007 Tara 8Yr Tara Kinderkutje) (Pedo) (Ptsc)_to_DivX_clip0
 - This video file depicts one (1) prepubescent female child approximately 6-10 years old and (1) adult male on a bed. The female child is nude and the male is only wearing a shirt. When the video begins, there is music playing and the female child lying on her stomach. The adult male is standing with one leg on the ground and one knee on the bed. The male has his penis inserted into the mouth of the female child and he is thrusting the female child's head forward and backward, while holding the back of her head. At 00:12 into the video, the camera is turned off and turned back on, then showing the male laying on his back, while the female child is performing oral sex on the male. At 00:37, the camera again turns off and on, then showing them female child on her back, while the male, now nude, is performing oral sex on the female child. The camera is stationary during these scenes. At 1:04, the camera turns off and on, then showing a close shot of the female child performing oral sex on the adult male. At 01:29, the camera shuts off and on, then showing the adult male on his knees on the bed, while the female child is performing oral sex on him. At 02:22 the camera turns off and on, then showing a close up of the female child performing oral sex on the adult male. At 02:35, the camera shows the adult male ejaculating onto the face of the female child while she covers her face with her hands. The camera then turns off and the a blue screen appears with text boxes that read, "starring 8 year old tara," and, "all footage shot December 31st, 2006."

I, Special Agent Walter Mahone, viewed this file and found it to be an approximately 3 minute child sexual abuse video. In my training and experience, this video is child exploitation material.

- File Name: ! New ! (Pthc) (Kinderkutje) 2007 Tara 8Yr The Sensual Side
- This video file depicts one (1) prepubescent female child approximately 6-10 years old lying on her back, on a bed. The female child is wearing a purple mask and is nude. The camera is being held by an unknown person and there is music playing. The female child

begins to digitally penetrate her vagina while lying on her back. The person holding the camera then moves closer to the female child while she continues to masturbate. For the remainder of the video, the child moves around and poses in various ways while the person holding the camera moves closer and further away repeatedly. The camera is turned off at 05:59 and a blue screen appears with text boxes that read, "starring 8 year old Tara," and, "filmed April 4th, 2007," and, "music by Enigma."

I, Special Agent Walter Mahone, viewed this file and found it to be an approximately 6 minute child pornographic video. In my training and experience, this video is child pornography.

On December 2, 2019 a Criminal Subpoena was served upon Cobridge Communications (which is owned and operated by Fidelity Communications), the internet service provider (ISP) of IP address 170.10.43.93. The subpoena requested the subscriber records for IP address 170.10.43.93, during specific dates and times, that IP address was offering to participate in the distribution of known child exploitation material.

On December 16, 2019 Fidelity Communications provided the subscriber information for IP address 170.10.43.93, showing it was assigned to David Brown, with a service address of 912 Fox Rridge Dr, Benton, Arkansas 72019, during the dates and times provided in the subpoena.

On May 7, 2020 I went to Brown's house at 912 Fox Ridge Dr. and spoke with him. SA Slaton read Brown his Miranda Rights and Brown signed a department form stating that he understood his rights and that he would speak with us without an attorney present. During the conversation, Brown admitted to using "BitTorrent" to download pornography but stated it was adult and teen porn. Further, Brown told me that he has caught his son watching pornography and possibly child pornography on his computer. Brown then told me that when he searched for pornography on "BitTorrent" he would search for fetish items such as "brother/sister" and "women in public" using a computer in his home. During the investigation, it was discovered that Brown has two sons that are both high school aged. Brown stated that his sons typically stay at his house every other week, but that they don't have a regimen. Brown stated that he and his wife are still legally married but she does not live with him. While SA Slaton and I were on the porch, SA Slaton looked at the surrounding Wifi signals and saw that all were locked and password protected.

On May 7, 2020, I, along with agents from the Arkansas Attorney General's Office, Officers from the Benton Police Department, and a Detective from the Little Rock Police Department, executed a search warrant on Brown's residence, at 912 Fox Ridge Dr. During the execution of the warrant, a 16GB USB flash drive was located in the computer area of Brown's home. During the warrant, a 16GB usb flash drive was located in the computer area of Brown's home. During a forensic preview of the drive, a number of child pornographic images were found. In total, there are 17 images found that, through my training and experience, I recognize as child pornography. Of those 17 images, 15 of them were deleted from the drive, but our forensic tools were able to recover the data. The two "live files" that were not deleted both depicted prepubescent female children posing nude. Also found within the contents of the flash drive were tax documents belonging to David Brown. The tax documents showed Mr. Brown's social security number, address, and other personal information.

Also, during the search, I located a feather mask in a bed side table that is very similar to the mask worn by a male during the above aforementioned videos, otherwise known as the "Tara"

series of child pornography. In the "Tara" series, the father of a young girl named Tara wears a series of feather "Mardi Gras" style masks while he sexually assaults his daughter.

I believe that the facts and circumstances described above constitute probable cause that David Jefferson Brown has violated the criminal law of the State of Arkansas by committing the criminal offense(s) of: Distributing, possessing, or viewing of matter depicting sexually explicit conduct involving a child, Ark. Code Ann. 5-27-602(a)(2) Classification C
