Only vendors registered in Wisconsin e-Supplier Portal are guaranteed to receive notice of State of Wisconsin solicitation opportunities in their commodity or service area. If you were previously registered on the VendorNet system, you will still need to register on the eSupplier Portal to receive notification and participate in the bid process.

If you register on the Wisconsin e-Supplier Portal <u>AFTER</u> the posting of this RFB, you must return through the Wisconsin e-Supplier Portal to view the Questions and Answers document or any amendments that may have been posted.

The RFB once posted, will be viewable at the Public Notice site, however in order to respond electronically to the RFB you must be registered on the Wisconsin e-Supplier Portal.
