State Opioid Response 2.0 Funding Detail

To advance Ohio's efforts in combatting the drug crisis, the Ohio Department of Mental Health & Addiction Services (OhioMHAS) is granting \$76,534,000 in new federal aid for strategic efforts in local communities. Of that, \$58,884,000 is being granted directly to local ADAMH Boards for their collaborative work with community partners focused on substance abuse and mental illness. The funding, which is part of Ohio's overall share of \$96 million in federal State Opioid Response 2.0 funding, comes at a time when many communities are seeing a spike in demand for behavioral health services amid the ongoing coronavirus pandemic. Additional funding for innovations in approaches to connecting people to care will be made available by OhioMHAS as part the SOR 2.0 investments.
