

OCRA's COVID-19 Response Grant Program - Phase 3

Grants for job retention

The **Town of Bainbridge** is awarded \$153,840 to provide grants to small businesses located within town limits that the COVID-19 pandemic has negatively impacted.

The **City of Bedford** is awarded \$250,000 to provide up to \$10,000 grants to small businesses, including retail and commercial businesses affected by the COVID-19 pandemic.

Benton County is awarded \$250,000 to grant funds up to \$10,000 to local businesses to use for working capital, continue operations and support remote work to retain employees.

Blackford County is awarded \$250,000 to assist its hardest-hit manufacturers and retail businesses.

The **City of Boonville** is awarded \$250,000 to award grants to assist businesses in retaining positions held by at least 51% LMI persons.

The **Town of Cayuga** is awarded \$225,640 to provide grants to small businesses located within town limits that have been negatively impacted by the COVID-19 pandemic.

The **Town of Chandler** is awarded \$250,000 to award grants to small businesses located within 2 miles of the corporate limits to assist the businesses in retaining positions held by at least 51% LMI persons.

The **Town of Clarksville** is awarded \$250,000 to provide grants to small businesses (with 100 employees or less), not to exceed \$10,000 per business.

Clay County is awarded \$250,000 to provide grants to small businesses located within county limits that have been negatively impacted by the COVID-19 pandemic.

The **Town of Corydon** is awarded \$250,000 to grant up to \$10,000 to small businesses that have been most severely impacted by the economic downturn due to COVID-19.

Decatur County is awarded \$250,000 to grant between \$5,000 and \$10,000 to small businesses with fewer than 50 employees located in Greensburg, Millhousen, New Point, St. Paul, Westport and unincorporated Decatur County.



The **City of Delphi** is awarded \$250,000 to provide grants to at least 15 small businesses to assist with payroll and operating costs.

The **Town of Elberfeld** is awarded \$250,000 to award grants to small businesses located within 2 miles of the corporate limits to assist the businesses in retaining positions held by at least 51% LMI persons.

Fayette County is awarded \$250,000 to create a grant program that will aid the county's hardest-hit manufacturing, retail and service sector businesses.

The **Town of Fort Branch** is awarded \$250,000 to award grants to small businesses located within 2 miles of the corporate limits to assist the businesses in retaining positions held by at least 51% LMI persons.

The **City of Gas City** is awarded \$250,000 to provide grants to the hardest retailers, service sector businesses, and small manufacturers with working capital to reopen businesses, continue operations, expand their payroll, restock inventory or pay for remote working technology.

Gibson County is awarded \$250,000 to award grants to small businesses located in Gibson County. The grant funds will assist the businesses in retaining positions held by at least 51% LMI persons.

The **City of Greencastle** is awarded \$250,000 to provide grants to small businesses located within city limits that have been negatively impacted by the COVID-19 pandemic.

Greene County is awarded \$200,000 to provide grants to assist businesses to remain operational and support remote work for businesses due to the impacts of COVID-19.

Harrison County is awarded \$250,000 to grant up to \$10,000 to small businesses that have been most severely impacted due to the COVID-19 pandemic.

The **Town of Haubstadt** is awarded \$150,000 to award grants to small businesses located within 2 miles of the corporate limits to assist the businesses in retaining positions held by at least 51% LMI persons.



Henry County is awarded \$250,000 to grant up to \$10,000 to small businesses with revenue equal to or less than \$1 million and employers with 100 employees or less who have been affected by the COVID-19 pandemic.

The **Town of Jamestown** is awarded \$250,000 to provide grants to small businesses located within town limits that have been negatively impacted by the COVID-19 pandemic.

The **City of Jeffersonville** is awarded \$250,000 to award grants to assist businesses in retaining positions held by at least 51% LMI persons.

Jennings County is awarded \$250,000 to provide grants up to \$10,000 to eligible for-profit businesses to assist with job retention.

The **City of Knox** is awarded \$200,000 to manage a grant program for businesses impacted by the COVID-19 pandemic to assist them in retaining jobs and keeping their businesses open.

LaGrange County is awarded \$250,000 to provide grants up to \$10,000 to businesses in the county. The grants must be used for working capital needs.

The **Town of Lynnville** is awarded \$125,000 to award grants to small businesses located within 2 miles of the corporate limits to assist the businesses in retaining positions held by at least 51% LMI persons.

The **City of Madison** is awarded \$250,000 to continue the successful Small Business Assistance Grant program initiated in 2020 to provide businesses with grants between the amounts of \$5,000 and \$10,000.

Martin County is awarded \$250,000 to assist local businesses throughout the county by providing financial assistance to businesses that have been negatively affected by the COVID-19 pandemic.

The **City of Monticello** is awarded \$250,000 to provide grant funds to local businesses within the City of Monticello to provide financial assistance for payroll and other operational costs.

The **City of Mount Vernon** is awarded \$250,000 to award grants to small businesses to assist businesses in retaining positions held by at least 51% LMI persons.



The **Town of Nashville** is awarded \$250,000 to grant up to \$10,000 to small businesses that have been most severely impacted by the COVID-19 pandemic.

The **City of New Albany** is awarded \$250,000 to grant up to \$10,000 to small businesses that have been most severely impacted due to the COVID-19 pandemic.

The **Town of New Harmony** is awarded \$250,000 to award grants to small businesses to assist businesses in retaining positions held by at least 51% LMI persons.

The **Town of Newburgh** is awarded \$250,000 to award grants to small businesses of the town to assist the businesses in retaining positions held by at least 51% LMI persons.

Noble County is awarded \$200,000 to continue a grant program, made possible by an OCRA COVID-19 Relief Phase I grant, to target at-risk small businesses in the county.

The **Town of North Judson** is awarded \$200,000 to start a grant program for businesses impacted by the COVID-19 pandemic to assist them in retaining jobs and keeping their businesses open.

The **Town of North Vernon** is awarded \$250,000 t to provide grants up to \$10,000 to eligible for-profit businesses to assist with job retention.

The **City of Oakland City** is awarded \$180,000 to award grants to small businesses to assist businesses in retaining positions held by at least 51% LMI persons.

Pike County is awarded \$250,000 to offer grants of up to \$10,000 to at least 25 small businesses in Pike County to retain low-to-moderate income jobs.

Posey County is awarded \$250,000 to award grants to small businesses of the county to assist the businesses in retaining positions held by at least 51% LMI persons.

The **City of Princeton** is awarded \$250,000 to award grants to small businesses of the city to assist them in retaining positions held by at least 51% LMI persons.

Pulaski County is awarded \$250,000 to provide grants up to \$10,000 to assist small businesses in the community that have been impacted by the COVID-19 outbreak.



Putnam County is awarded \$250,000 to provide grants to small businesses located within Putnam County limits that have been negatively impacted by the COVID-19 pandemic.

The **Town of Remington** is awarded \$250,000 to assist, at minimum, 25 businesses with grants to provide financial assistance for payroll and other operational costs.

Ripley County is awarded \$250,000 to provide \$10,000 grants to assist any eligible business located with the county with less than 100 employees that have been negatively impacted by the COVID-19 pandemic. Businesses located on the Franklin County portion of Batesville are also eligible to apply.

The **City of Rushville** is awarded \$250,000to provide \$10,000 grants to any eligible business located within the city with less than 100 employees that have been negatively impacted by the COVID-19 pandemic.

Scott County is awarded \$250,000 to assist small businesses in Scott County that have been economically impacted by the effects of the COVID-19 pandemic.

The **City of Scottsburg** is awarded \$250,000 to grant up to \$10,000 to small businesses that have been most severely impacted by the COVID-19 pandemic.

The **Town of Seelyville** is awarded \$153,840 to provide grants to small businesses located within town limits that have been negatively impacted by the COVID-19 pandemic.

Shelby County is awarded \$250,000 to award grants for up to \$10,000 to small businesses with fewer than 50 employees located within Shelby County that have been negatively impacted by COVID-19.

The **Town of Thorntown** is awarded \$250,000 to provide grants to businesses that have been hit hard by the pandemic by assisting with operating expenses.

Union County is awarded \$250,000 to will provide grants for working capital for businesses to reopen or continue operations, restock inventory, expand payrolls, or pay for remote work technology.

The **City of Valparaiso** is awarded \$250,000 to offer grants of up to \$10,000 to businesses as short-term working capital to retain jobs held by LMI persons, continue operations and support remote work.



Vanderburgh County is awarded \$250,000 to award grants to small businesses located in Vanderburgh County to assist businesses in retaining positions held by at least 51% LMI persons.

Vermillion County is awarded \$250,000 to provide grants to small businesses located within county limits that have been negatively impacted by the COVID-19 pandemic.

Warrick County is awarded \$250,000 to award grants to small businesses located in Warrick County to assist businesses in retaining positions held by at least 51% LMI persons.

Wayne County is awarded \$250,000 to award grants to county businesses to either reopen a business, continue operations, expand payroll, restock inventory or pay for remote work technology.

White County is awarded \$250,000 to provide grant funds to local businesses within White County to provide financial assistance for payroll and other operational costs.

The **Town of Winamac** is awarded \$153,840 to provide grants to businesses in the community that have been hard-hit by the pandemic.

Loans for job retention

The **City of Angola** is awarded \$250,000 to assist small businesses in addressing the issues presented by COVID-19 and provide low-interest loans to businesses in the retail and restaurant sector.

Mental health

Allen County is awarded \$250,000 to fund mental health services for adult women who have experienced substance use disorders, adults who have experienced domestic violence and their children.

Howard County is awarded \$250,000 to fund the county's current system of care by increasing access to mental health, domestic violence and substance abuse services for community members.

Miami County is awarded \$100,000 to provide grant funds to assist mental health support services to families by providing initial screening and evaluations, one-on-one counseling



sessions, support to families for mental health barriers, and resource materials to help clients cope with the challenges they face during the COVID-19 pandemic.

Food pantry/bank service

Knox County is awarded \$250,000 to assist with Helping His Hands Disaster Response, Inc. to expand its food pantry services to better serve residents of Knox County.

The **Town of Oxford** is awarded \$120,000 to assist the Benton Community Food & Service Coop to purchase food to distribute to families in need. The grant will fund \$10,000 of food per month for 12 months. The food will be distributed at three sites in the Town of Oxford.

Parke County is awarded \$250,000 to fund the Food Security Alliance of Parke County to address food insecurity and build capacity in these programs to improve the health of our foodinsecure residents.

The **Town of Wolcott** is awarded \$250,000 to work with the Wolcott Christian Church, grant subrecipient, to reactivate its food pantry program.

WiFi/Broadband

The **City of Evansville** is awarded \$245,552 to improve and expand the current public WiFi infrastructure narrowing the access gap that exists within the city's high-poverty and historically underserved neighborhoods.

Tippecanoe County is awarded \$127,075 to install three new WiFi hot spots in the county, allowing residents to walk up or pull up in vehicles and connect to the internet while also following social distancing recommendations.

Child care

The **City of Peru** is awarded \$100,000 to provide assistance to licensed childcare providers located within the city limits.

Randolph County is awarded \$250,000 for daycare funding to provide scholarships to low-income families, provide payroll assistance, purchase PPE, and assist daycare centers negatively impacted by the COVID-19 pandemic.



Multiple Eligible Activities

The City of Brazil is awarded \$250,000 for food pantry distribution services coordinating with the Clay County Emergency Food Pantry and General Mental Health Services partnering with Child Adult Resource Services, Inc. (C.A.R.S.) to hire two full-time staff members. The funds will also help with the purchase of 20 iPad tablets.

The **Town of Brookville** is awarded \$250,000 to provide grants to small businesses and expand WiFi to the residents of Brookville.

The City of Charlestown is awarded \$250,000 to establish a grant program to assist local businesses with working capital and to support a Social Worker Contract temporary position to act as a community liaison for mental health services.

The City of Connersville is awarded \$250,000 to provide funds to either reopen a business, continue operations, expand payroll, restock inventory or pay for remote work technology. Additionally, funds will be allocated to create three new WiFi hot spots in the city.

Fulton County is awarded \$250,000 to provide grants to businesses and food banks located within the county's jurisdictional boundaries.

Starke County is awarded \$250,000 to provide grants for businesses impacted by the COVID-19 pandemic to assist them in retaining jobs and keeping their businesses open. Starke County will also distribute food boxes to families.
