IHCP updates FQHC and RHC encounter codes

Effective July 1, 2021, the Indiana Health Coverage Programs (IHCP) will include the Current Procedural Terminology (CPT^{®1}) and Healthcare Common Procedure Coding System (HCPCS) codes in Table 1 as valid federally qualified health center (FQHC) and rural health clinic (RHC) encounter codes. This update applies retroactively to claims with dates of service (DOS) on or after Jan. 1, 2021.

Beginning July 1, 2021, FQHC and RHC providers may submit claims for these codes with DOS on or after Jan. 1, 2021. Claims for these codes with DOS on or after Jan. 1, 2021, that were previously denied may be resubmitted. Claims submitted beyond the original 180-day filing limit must include a copy of this bulletin as an attachment and must be filed within 180 days of the publication date.

The IHCP will remove the nationally deleted codes in [Table 2](#) from the list of valid FQHC and RHC encounter codes. This change applies retroactively to claims with DOS after Dec. 31, 2020. This change will have no impact on previously adjudicated claims.

Table 1 – Procedure codes added as valid FQHC and RHC encounter codes, effective for DOS on or after Jan. 1, 2021

Procedure code	Description
57465	Computer-aided mapping of cervix during examination of vagina and cervix using endoscope
90785	Psychotherapy, interactive complexity
90899	Psychiatric service or procedure
96165	Health behavior intervention, group, face-to-face; each additional 15 minutes
96171	Health behavior intervention, family (without the patient present), face-to-face; each additional 15 minutes
D1355	Caries preventive medicament application - per tooth
D3471	Surgical repair of root resorption - anterior
D3472	Surgical repair of root resorption - premolar
D3473	Surgical repair of root resorption - molar
D3501	Surgical exposure of root surface without apicoectomy or repair of root resorption - anterior

Procedure code	Description
D3502	Surgical exposure of root surface without apicoectomy or repair of root resorption - premolar
D3503	Surgical exposure of root surface without apicoectomy or repair of root resorption - molar
D7961	Buccal/labial frenectomy (frenulectomy)
D7962	Lingual frenectomy (frenulectomy)
G0444	Annual depression screening, 15 minutes
G0466	Federally qualified health center (FQHC) visit, new patient
G0467	Federally qualified health center (FQHC) visit, established patient
G0468	Federally qualified health center (FQHC) visit that includes an initial preventive physical examination (IPPE) or annual wellness visit (AWV)
G0469	Federally qualified health center (FQHC) visit, mental health, new patient
G0470	Federally qualified health center (FQHC) visit, mental health, established patient
H0015	Alcohol and/or drug services; intensive outpatient (treatment program that operates at least 3 hours/day and at least 3 days/week and is based on an individualized treatment plan), including assessment, counseling; crisis intervention, and activity therapies or education
H2011	Crisis intervention service, per 15 minutes
