### Small Shipment Redistribution Program (SSRP) Overview

**Background**: Supply of the COVID-19 vaccine is now outpacing demand across the Commonwealth. In the spirit of continuing to expand access and boost vaccination rates, small providers like Primary Care Physicians and Pediatricians have the advantage of being trusted healthcare advisors to present a pathway for their patients to receive the vaccine in a comfortable and familiar space.



#### **OVERVIEW**

The Small Shipment Redistribution

Program (SSRP) is a voluntary network of geographically dispersed providers who coordinate with a central distribution center (hub) to order substantially smaller quantities of the vaccine than is available through direct federal shipments. Coordination is managed by the central pharmacy team and the allocation team.

Providers must be enrolled with VDH (have a VTrcKs ID) to order a redistribution shipment.



# BENEFITS TO PROVIDERS

The SSRP allows Primary Care
Physicians, Pediatricians, and
independent medical practices to have
access to a constant supply of small
shipments of the COVID-19 vaccine.
Program participation will enable
providers to maximize opportunistic
administrations in a trusted setting
for their patients not yet vaccinated.
Vaccine supply is provided by the
federal allotment of COVID-19 doses,
so they will remain free to all providers
and hubs.



#### **OTHER DETAILS**

**Target Participants:** Primary care physicians, pediatricians, independent pharmacies

Vaccine Type: Pfizer

**Shipment Frequency:** Every other week, or less

frequently if necessary

Minimum Quantity: 1 vial

**Maximum Quantity:** 4 vials of the 5-11 pediatric vaccine or 15 vials of the 12+ vaccine.

Initial Ordering process: Providers looking to

participate will make requests in the same Provider
Request Portal where ordering regular VaxMaX
shipments is done

**Note:** providers looking to order more than the SSRP maximum quantity must order through the normal channels.

# Small Shipment Redistribution Program (SSRP) - Distribution & Ordering

#### **Federal Warehouse**

- Doses will be sourced from the State's federal allocation
- Distribution to the Central Distribution Centers will be federally funded

#### **Central Distribution Center**

- A central distribution (DC) center can accept direct shipments, break them down, and can send them directly to the sites
- A central DC will be equipped with ultra-cold freezers
- Distribution to the individual providers will be supported by the Commonwealth

#### **Individual Providers**

- SSRP is now fully integrated into VaxMax
- Providers will order their doses through VaxMax
- Order cadence for SSRP begins on Thursdays at 7:00 AM and closes at 5:00 PM on Fridays, the following day

#### **Order Mechanism:**

- Only Pfizer COVID-19 vaccines will be available for ordering
- Individual providers will order the doses expected to cover 10 weeks of demand (duration Pfizer is good under refrigeration)
- The amount ordered per individual provider can be between 1 and 15 vials of the 12+ vaccine or 1 to 4 vials of the under 5 11 vaccine
- Vaccine will be distributed to providers under **frozen conditions** (for purple cap Pfizer) or **under refrigerated conditions** (for gray cap and orange cap Pfizer). The cooler containing a **data logger** to monitor temperature conditions is shipped via UPS Next Day Air
- Each cooler will contain a return label for return shipping of the cooler and data logger
- Ancillary kits will be broken down and shipped via UPS Ground same day as vaccine or day prior
- Note: this is not meant to replace the normal ordering procedures; if a provider is able to handle standard shipping quantities, providers should do so



# Small Shipment Redistribution Program (SSRP) – Ordering Process

Use <u>VaxMax</u> to place your SSRP orders. Providers will require their VTrcKS ID



**Request Vaccine**: request COVID-19 Vaccines (all dose types)

 Note: Option will be available during the SSRP open request period beginning on Thursday 7am through Friday at 5pm ET. Provider requests will be disabled outside of this window.

- Register to Redistribute: register for redistribution across providers
- Report Redistribution: report redistributions between providers
- Report Inventory or Delivery Error: capture and communicate data issues or delivery errors in the reports
- Link to Report Wastage: link to access COVID Vaccine Wastage form
