Covid-19 Self-Test Instru...

Have you or anyone in your household developed symptoms of COVID-19: new continuous cough (coughing frequently for more than an hour, or 3 or more coughing episodes in 24 hours) and/or high temperature and/or a loss of, or change in, normal sense of taste or smell (anosmia).

NO

Take an LFD Test.

This should be done:

- ✓ twice weekly
- √ 3-4 days apart as agreed with your setting
- ✓ in the morning before you leave for work.

If you have had a Covid-19 vaccination you <u>can</u> still take an LFD test.

If staff have recently (within 90 days) had a positive PCR test for COVID-19 they are exempt from testing by both PCR and LFD within 90 days of a positive PCR test, unless they develop new symptoms. Individuals may choose to take a LFD test after the isolation period.

Read your test result at 30 minutes (not before or after).

Inform your setting of your result so they can start contact tracing if staff member was in setting in previous 48 hours and notify the LA via the usual notification form.

YES

DO **NOT** use the LFD Test and DO **NOT** go to the setting. Book a standard PCR test as soon as possible for you or anyone in your household with symptoms. This can be done online at:

www.nhs.uk/coronavirus.

Please do not let anyone from your household go into a setting or work until the test result is known.

Alternatively a test can be ordered by phone on NHS 119 for those without the internet.

Positive Result

Inform your setting.

You and your household must self isolate for 10 days from start of symptoms or date of LFD test as per Government guidelines.

Negative Result

You can return to setting and your household can stop isolating. Restart twice weekly LFD testing.

POSITIVE LFD TEST RESULT You and your household must self isolate whilst waiting for the result.

Book a PCR test asap online at

CAUTION Go into the setting as

normal and continue to take all current precautions. The test did not detect COVID-19 but rapid tests miss some infections. A negative test does not rule out coronavirus infection.

LFD TEST RESULT

If 1st void result: repeat using a new LFD test kit. If 2nd test result is void: book a PCR test and inform the setting. You **DO NOT** need to selfisolate unless PCR

is positive.

- LFD tests are used for identifying asymptomatic cases and should not be used if you have any symptoms.
- LFD tests are safe to use in pregnancy.
- If you have had a Covid-19 vaccination you should still take part in the LFD testing as you may still transmit the virus.
- If you have been identified as a close contact of a positive case, a negative LFD test does not mean you can stop isolating.
- If you have had a recent nosebleed, or have a nose piercing use the other nostril to swab for
