| 21 | which expressly grants the authority to individual states to                                       |
| 22 | determine the manner of appointment of the state's allotment of                                    |

<sup>1</sup> WHEREAS, although the United States Constitution limits the role <sup>2</sup> of Congress with respect to regulation of congressional elections to <sup>3</sup> acting as a check on state legislatures, H.R. 1 represents an <sup>4</sup> overreach of congressional authority by the attempt to seize <sup>5</sup> principal regulatory authority over congressional elections in the <sup>6</sup> states by overriding state voter identification laws and by imposing <sup>7</sup> mandates related to absentee voting and voter registration; and

8 WHEREAS, despite the enactment in thirty-five states of statutes 9 requiring some form of documentary personal identification for the 10 exercise of voting rights, H.R. 1 impairs protections that voter 11 identification requirements provide against interference with voting 12 rights by dismantling meaningful voter ID laws to allow a statement 13 instead of a previously issued document-supported form of 14 identification to ensure that voters are eligible to vote in an 15 election; and

<sup>16</sup> WHEREAS, H.R. 1 increases the potential for voter fraud by <sup>17</sup> mandating nationwide automatic voter registration and Election Day <sup>18</sup> voter registration, which would enable non-citizens and other <sup>19</sup> persons ineligible to vote to cast fraudulent ballots before <sup>20</sup> precautionary measures can be taken by election officials; and

WHEREAS, state and county election boards ensure election
integrity with the maintenance of voter registration rolls by the
routine removal of the registrations of citizens who have not voted
in multiple consecutive elections and who fail to respond to

<sup>1</sup> numerous efforts to confirm residency. H.R. 1 attacks reliable <sup>2</sup> methods of maintenance of voter rolls by prohibiting the use of <sup>3</sup> voter inactivity and lack of response to remove invalid voter <sup>4</sup> registrations without authorizing reasonable and reliable <sup>5</sup> alternatives; and

6 WHEREAS, H.R. 1 removes accountability from the process of 7 congressional redistricting by mandating the drawing of new boundary 8 lines by "independent commissions" instead of state legislatures, 9 thus eliminating the ability of the people to hold the decision-10 makers accountable in upcoming elections.

NOW, THEREFORE, BE IT RESOLVED BY THE SENATE OF THE 1ST SESSION OF THE 58TH OKLAHOMA LEGISLATURE:

13 THAT the Oklahoma State Senate urges Members of the United 14 States Senate to exercise due consideration of the constitutional 15 deficiencies contained in H.R. 1 and any companion legislation in 16 the United States Senate and the critiques by state and local 17 election officials of the policies of election administration 18 included in the legislation.

19 THAT the Oklahoma State Senate urges Members of the United 20 States Senate to defend the integrity of elections in this country 21 and promote voter confidence in the electoral system by withholding 22 support for H.R. 1 and any companion legislation in the United 23 States Senate.
