SUBJECT: Shared Revenue Payments and Local Government Public Safety Expenditures

At your request, this memorandum provides information on shared revenue payments received by local governments in Wisconsin since 2001. The memorandum also provides information on local government expenditures for the purpose of public safety since 2001.

Shared Revenue and Utility Aid

In 2004, the current county and municipal aid program replaced the former shared revenue program as the largest local assistance program for counties and municipalities. The program continues to be referred to as shared revenue. Prior to 2002, shared revenue payments were based on a formula. However, since 2002, this formula has not been in effect. As a result, except in years when funding levels change with legislation, counties and municipalities receive the same amount of county and municipal aid as the prior year, subject to specific statutory reductions.

Table 1 below shows the total amounts of shared revenue received by each local government type in each year between 2001-2021. The table also shows the totals paid to all municipality types combined, as well as statewide totals. The table does not reflect the \$4.0 million reduction to Milwaukee County's county and municipal aid payment which is intended to offset a portion of the state's contribution toward the construction of the new Bucks arena, or other smaller adjustments to county and municipal aid.

Public Safety Expenditures

You also requested information on the amounts expended by local governments for the public safety purposes. Table 2 below displays the total amounts expended for the provision of police services, fire services, emergency communications (911), ambulance services, and correctional facilities by towns, villages, cities, and counties, as well as municipal and statewide totals for odd-numbered years between 2001-2019. This information is gathered from the Municipal Finance Report submitted to the Department of Revenue.

It should be noted that in some years, entire towns may incorporate, or portions of towns may be annexed, into villages or cities. In such cases, those municipalities' expenses would be reflected in the total for villages or cities, rather than towns, which could result in an apparent decrease in the total amount expended by towns. Additionally, public safety functions are not uniformly provided by all local governments. Some local governments may enter into agreements to either jointly provide public safety services or use the public safety services provided by other governments.
