# Notice of Availability NOTICE OF 3<sup>rd</sup> 15-DAY PUBLIC COMMENT PERIOD PROPOSED REVISIONS TO THE AIR FILTERS REGULATIONS

On March 25, 2022, the California Energy Commission (CEC) published a Notice of Proposed Action with proposed amendments to the air filters regulations contained in the California Code of Regulations, Title 20. The CEC made all the documents available for a 45-day comment period, which ended on May 9, 2022, and held a public hearing on May 10, 2022.

On August 22, 2022, the CEC published a public notice announcing a 15-day comment period for changes to the proposed regulation for air filters. Due to a technical issue concerning outreach, a second public notice was published on August 29, 2022, updating the August 22, 2022, public notice. Comments were received into the docket during the updated public comment period, which concluded on September 13, 2022.

On October 28, 2022, the CEC published a public notice announcing a 2<sup>nd</sup> 15-day comment period for the changes to the proposed regulation for air filters. Comments were received into the docket during the public comment period, which concluded on November 14, 2022.

Based on the comments received during the 2<sup>nd</sup> 15-day comment period, the CEC is proposing additional changes to the proposed regulatory language offered on March 25, 2022; August 29, 2022; and as proposed to be modified on October 28, 2022. **Any interested persons are invited to review and provide written comments to the CEC for consideration during the 3rd 15-day comment period from December 2, 2022, through December 20, 2022.** The CEC appreciates receiving written comments at the earliest possible date.

The amendments proposed under this third 15-day notice are shown in italics double-strikethrough dot-dot-dash underline (example) to indicate deletions and italics dot-dot-dash underline (example) to indicate additions.

# **Summary of Modifications**

### Section 1607:

 Necessary changes were made to the language clarifying the visibility requirements of the marking. The change was considered necessary to avoid any ambiguity on the intent of the regulation.

### Summary of recommendations not implemented

### Section 1602:

- The recommended changes to the Air Filter definitions were not implemented because the recommendations either added ambiguity or were deemed redundant since the language suggested is part of a defined term currently used in section 1602(c) of Title 20.

### Section 1606 & 1607

- The recommendation to further delay the effective date of July 1, 2024, was not implemented because CEC considers the current effective date to provide manufacturers with ample time to make the necessary changes to provide stores with the necessary information on filters manufactured prior to July 1, 2024.
- CEC staff also concluded that the new amendments discussed in this public notice will not require the further delay of the effective date of July 1, 2024, because manufacturers will have ample time for compliance with a January 25, 2023, adoption.
