Rulemaking Overview

- Repeal portable luminaires as regulated appliance (Title 20)
- Requirements made redundant by recent lighting regulations
- No changes to any other appliance types





Proposed changes

- Remove the following related to portable luminaires:
 - Definitions
 - Testing requirements
 - Performance standards (including the “bulb-in-box” requirement)
 - Marking requirements
 - Data submittal requirements



Certification

- Portable luminaires will no longer be required to certify to MAEDbS
- Future submissions will not be possible
- All currently certified models will be moved to the “archived” database



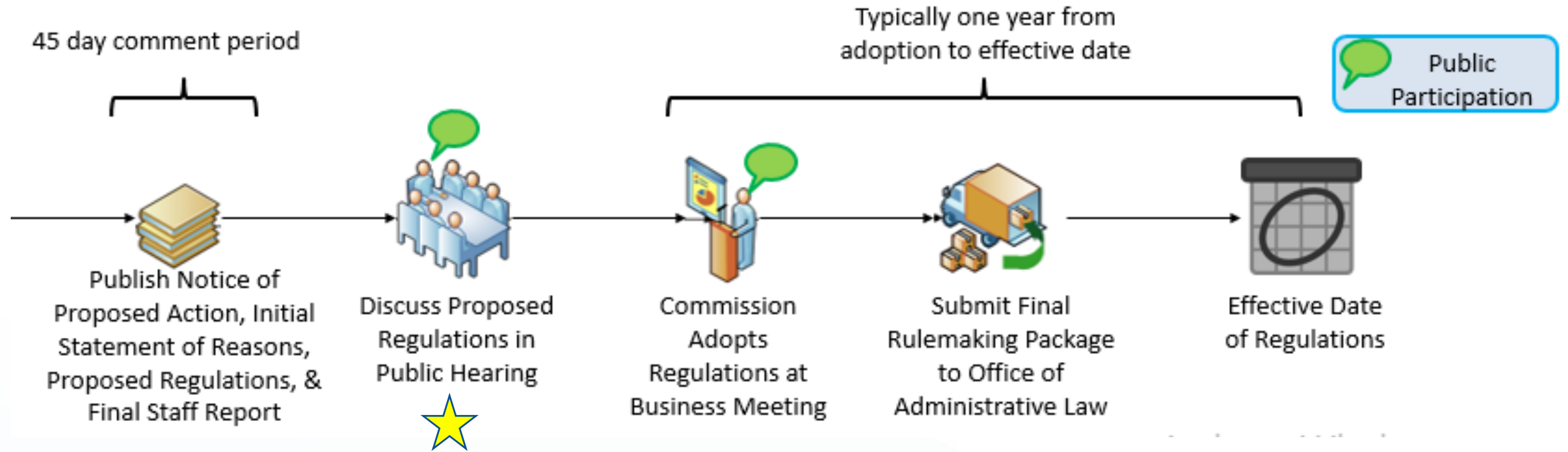
Other Lighting Regulations

- The light bulbs (lamps) used with portable luminaires will continue to be regulated:
 - State-regulated LED lamps
 - State-regulated small diameter directional lamps
 - General service lamps
