PROCLAMATION

RY THE

Governor of the State of Texas

TO ALL TO WHOM THESE PRESENTS SHALL COME:

WHEREAS, the power of impeachment is vested in the Texas House of Representatives by Article XV, Section 1 of the Texas Constitution; and

WHEREAS, on May 27, 2023, the Texas House of Representatives adopted House Resolution No. 2377 to prefer articles of impeachment against Warren Kenneth Paxton, Jr., Attorney General of Texas; and

WHEREAS, a certified copy of such articles of impeachment was delivered to the Senate on May 29, 2023; and

WHEREAS, pursuant to Article XV, Section 2 of the Texas Constitution, impeachment of the Attorney General shall be tried by the Texas Senate in due course; and

WHEREAS, there now exists a vacancy in the office of Attorney General by operation of Article XV, Section 5 of the Texas Constitution, which dictates that all officers against whom articles of impeachment may be preferred shall be suspended from the exercise of the duties of their office during the pendency of such impeachment;

NOW, THEREFORE, I, Greg Abbott, Governor of Texas, by virtue of the authority vested in me by Article XV, Section 5 of the Texas Constitution, do hereby make a provisional appointment of The Honorable John Scott, former Texas Secretary of State, to serve as Attorney General until the decision on the impeachment.

In accordance with the statutory requirements, copies of this proclamation shall be filed with the applicable authorities.
