The California Energy Commission (CEC) Efficiency Division will host a public workshop to discuss proposed standards for landscape irrigation controllers and to seek comments from interested members of the public regarding the draft proposed regulations and the draft staff analysis report. The proposed standards for landscape irrigation controllers would be considered as amendments to the Appliance Efficiency Regulations (Title 20, Code of Regulations, Sections 1601 through Section 1609).

The public can participate in the workshop consistent with the attendance instructions below. The CEC aims to begin promptly at the start time posted and the end time is an estimate based on the proposed agenda. The workshop may end sooner or later than the posted end time.

The draft staff report, which includes the draft proposed regulations and the draft staff analysis, was published on November 8, 2023, and public comments will be accepted both orally at the workshop and in writing up to January 8, 2024. Instructions for accessing the draft staff report and for submitting comments are provided below.

The workshop will include presentations about the proposed standards and staff analysis for landscape irrigation controllers. Background

On March 14, 2012, the CEC issued an Order Instituting Rulemaking (OIR) to consider standards, test procedures, labeling requirements, and other efficiency measures to amend the Appliance Efficiency Regulations (California Code of Regulations, Title 20, Sections 1601 through Section 1609). The OIR identified a variety of appliances that have the potential to save electricity, gas, and water.

On April 21, 2017, the CEC released an "Invitation to Participate" to interested parties to gather information on the products, markets, and industry characteristics of the appliances identified. The CEC reviewed the information and data received in the docket and hosted staff workshops on July 19 through 21, 2017 to vet the information publicly.

On July 18, 2017, the CEC released an invitation to seek proposals for standards, test procedures, labeling requirements, and other measures to improve efficiency and reduce the energy or water consumption of specified appliances. The CEC reviewed the proposals received in the docket and hosted a staff webinar to vet those proposals on October 24, 2017.

On December 17, 2019, staff conducted a webinar on proposed water efficiency regulations for landscape irrigation controllers, including information related to definitions, test methods, and performance requirements. Staff invited stakeholders to join a CEC workgroup to gather comments on the proposal. Staff reviewed and considered all comments received.

Staff has evaluated all related stakeholder and other public comments and proposals, has conducted analyses of the comments, data, and proposals, and has prepared a draft staff report posted at
