- The revised Public Health Officer Safer at Home Order will require all businesses to provide essential workers with cloth face coverings. COVID-19 RELATED MEDICAL SHELTERING OPERATIONS New medical sheltering operations are currently being brought online. To increase capacity at each facility, the County is recruiting and training personnel to serve as on-site managers. Wrap around services including transportation, food, laundry services and security services are available at each site.

The County is working to quickly leverage incoming offers from local hotels/motels and solicitations for assistance in the COVID-19 response.

PERSONS EXPERIENCING HOMELESSNESS

The Office of Emergency Management has designated LAHSA as the lead agency for work relating to people experiencing homelessness. OEM did this to ensure that LAHSA's expertise is captured in the day-to-day work and allows LAHSA to play the central coordinating role across City and County agencies.

Medical Sheltering:

The County, with LAHSA's support seeks to provide 2,000 shelter beds where persons exhibiting COVID-19 symptoms can isolate safely. Medical sheltering sites will serve multiple populations, including persons experiencing homelessness. These sites include RVs provided by the state and hotels provided by the County. Physical Distancing in shelters continues to be a priority. LAHSA has requested resources that include food, personnel, test kits, and a warehouse to store acquired items. This request is currently being addressed by both the State and the County.

Project Roomkey:

Los Angeles County, LAHSA and the City of Los Angeles have collectively allocated \$39.3 million in state emergency homeless funding for Project Roomkey. Project Roomkey expands the County's interim shelter system in a massive public health effort that aims to bring as many people as possible inside to protect their health and prevent the spread of COVID-19. Hotels and motels will provide interim housing for vulnerable persons experiencing homelessness including those over 65 years of age and those with compromised immunity or chronic disease. LAHSA is currently standing up staffing and operations for Project Roomkey. The safety of clients and the staff at each hotel site is a priority. In accordance with physical distancing guidelines, arrivals to the hotels are staggered to avoid long lines and large gatherings at the point of entry for each of the hotels. Most sites will take 2-4 days to reach capacity under this model.

LOS ANGELES COUNTY HEALTH SERVICES & HEALTHCARE SYSTEM

The Los Angeles County Department of Health Services (DHS) released its **COVID-19 Hospital Demand Modeling Projections** showing that physical distancing is slowing the rate of COVID-19 transmission in the county. The projections indicate that if current levels of physical distancing are not maintained, there will be an exponential rapid increase in the rate of infection, severely hampering the ability of the hospital system to meet that demand. The insights from this modeling effort in large part informed the County of Los Angeles Dept. of Public Health's decision to extend the 'Safer at Home' order until May 15, 2020.

CONTINUITY OF OPERATION PLANS: (COOP)

Continuity of Operations Plans ensure the County of Los Angeles continues to support the residents of this county during any type of disaster response. Below is a list of County Departments and their status as it pertains to the COVID-19 local health emergency:

Agriculture/Weights and Measures: Continuing to provide services to public and industry. Facilities remain closed. For more information visit https://acwm.lacounty.gov/

Alternate Public Defender: Continuing with efforts to release clients housed by LASD, per court orders. Providing staff with safety protocols, facial covers, and enforcing facial covers in the workplace. Animal Care and Control: Providing services to the public, accommodating staffing needs for workers impacted by COVID-19, and reallocating resources to maintain operations. 16 staff assigned as DSWs and 11% of staff are teleworking. Reduced animal population by collaborating with adoption partner's, rescues, and public adoptions. Implementing appointment for adoptions, networking animals via social media, and allowing public and volunteers to foster animals to increase capacity. Assessor: Increasing telework capabilities and informing staff of the mandate to wear face masks. 85-95% of staff teleworking and implemented new advancements to serve the public in a safe environment. Auditor-Controller: Collaborating with eHR (payroll system) vendor and CGI to implement modifications to allow for the timely implementation of the Families First Coronavirus Response Act. The Shared Services and Payroll Divisions working with CEO and DHR for guidance and support regarding the proper coding of timecards for the Family Leave Act and Telework. 79% of staff are teleworking, 20 assigned as DSWs, and 4 in critical assignments. Beaches and Harbors: Continue oversight of beach and marina locations, while coordinating enforcement, beach closures, and information sharing with local public agencies and department vendors/leaseholds. Assisting in providing the public with information on beach closures. Mobilizing DSWs as needed for servicing and staffing of sheltering sites. Board of Supervisors: Adopted interim urgency ordinance, co-authored by Supervisor Mark Ridley Thomas and Supervisor Janice Hann to protect retail grocery, drug store and food delivery workers. Requires all retail grocery and drug stores to establish sanitary practices, workplace safety protections, provide sanitizing products and protective face coverings to protect vulnerable customers, members and delivery workers.

Approved proposal, written by Supervisor Hilda Solis and Supervisor Janice Hahn, to create an Emergency Rent Assistance Program. The program will provide up to \$1,000 per month for 3 months to renters who have lost income due to COVID-19.

Approved motion, co-authored by Supervisor Solis and Supervisor Kathryn Barger, to examine demographic data related to COVID-19 to collect full racial and ethnic data, age groups and socioeconomic status. The motion was amended by Supervisor Ridley-Thomas to collect data from all testing sites, with weekly updates.

Approved motion, authored by Supervisor Ridley-Thomas, to create the Los Angeles County COVID-19 Small Business Assistance Program. The program would provide funding for hundreds of small businesses and non-profits in LA County impacted by COVID-19.

Approved motion, co-authored by Supervisors Ridley-Thomas and Hahn, to develop a plan to keep vulnerable homeless seniors housed post-pandemic. For more information visit https://bos.lacounty.gov/.

Chief Executive Office: Collaborating with County partners to implement sheltering services for PEH. Coordinating transportation plan for PEH at sheltering facilities that may be experiencing COVID-19 symptoms. Providing logistical and administrative support for the operation of work groups. Coordinating with BOS to ensure that Board letters are reviewed and approved during periods when the regular Board meetings are disrupted.
