8 expenses of various agencies of the executive,

11 Board, the Alcoholic Beverage Laws Enforcement  
12 Commission, the Department of Corrections, the  
13 Oklahoma State Bureau of Investigation, the Council  
14 on Law Enforcement Education and Training, the Board  
15 of Medicolegal Investigations, the Oklahoma State  
16 Bureau of Narcotics and Dangerous Drugs Control, the  
17 Department of Public Safety, the Office of the  
18 Attorney General, the Court of Criminal Appeals,  
19 district attorneys and the District Attorneys  
20 Council, the Supreme Court, the Oklahoma Indigent  
21 Defense System, the Pardon and Parole Board, the  
22 Oklahoma Quick Action Closing Fund, The State  
23 Emergency Fund, the Rate Preservation Fund, the  
24 Maintenance of State Buildings Revolving Fund, the  
Digital Transformation Program Revolving Fund, and  
the Multiple Injury Trust Fund; stating amounts of  
the appropriations; stating purposes and  
restrictions; reappropriating certain funds;  
authorizing certain expenditures; and providing an  
effective date.

BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

EDUCATION

SECTION 1. There is hereby appropriated to the State Board of  
Education from any monies not otherwise appropriated from the  
General Revenue Fund of the State Treasury for the fiscal year  
ending June 30, 2021, the sum of Nine Hundred Fifty-three Million  
Three Hundred Thirty-eight Thousand Three Hundred Nineteen Dollars

1 . (\$953,338,319.00) or so much thereof as may be necessary for the  
2 financial support of public schools.

3 SECTION 2. There is hereby appropriated to the State Board of  
4 Education from any monies not otherwise appropriated from the  
5 Education Reform Revolving Fund created in Section 34.89 of Title 62  
6 of the Oklahoma Statutes, the sum of One Billion Fifteen Million  
7 Seventy-four Thousand Four Hundred Nineteen Dollars  
8 (\$1,015,074,419.00) or so much thereof as may be necessary for the  
9 financial support of public schools.

10 SECTION 3. The State Board of Education is hereby authorized to  
11 expend during the fiscal year ending June 30, 2021, from the Common  
12 Education Technology Revolving Fund of the State Treasury, the sum  
13 of Forty-six Million Nine Hundred Thirty-eight Thousand Five Hundred  
14 Sixty-six Dollars (\$46,938,566.00) or so much thereof as may be  
15 necessary for the financial support of public schools.

16 SECTION 4. There is hereby appropriated to the State Board of  
17 Education from any monies not otherwise appropriated from the  
18 Mineral Leasing Fund of the State Treasury for the fiscal year  
19 ending June 30, 2021, the sum of Three Million Eight Hundred  
20 Thousand Dollars (\$3,800,000.00) or so much thereof as may be  
21 necessary for the financial support of public schools.

22 SECTION 5. There is hereby appropriated to the State Board of  
23 Education from any monies not otherwise appropriated from the  
24 Mineral Leasing Fund of the State Treasury for the fiscal year

1 ending June 30, 2019, the sum of Five Million Four Hundred Eleven  
2 Thousand Two Hundred Fifty-eight Dollars (\$5,411,258.00) or so much  
3 thereof as may be necessary for the financial support of public  
4 schools.

5 SECTION 6. There is hereby appropriated to the State Board of  
6 Education from any monies not otherwise appropriated from the  
7 Oklahoma Education Lottery Trust Fund of the State Treasury for the  
8 fiscal year ending June 30, 2021, the sum of Twenty-three Million  
9 Seven Hundred Fifteen Thousand Dollars (\$23,715,000.00) or so much  
10 thereof as may be necessary for the financial support of public  
11 schools.

12 SECTION 7. There is hereby appropriated to the State Board of  
13 Education from any monies not otherwise appropriated from the  
14 Oklahoma Education Lottery Trust Fund of the State Treasury for the  
15 fiscal year ending June 30, 2019, the sum of Nine Million Twenty-  
16 four Thousand Four Hundred Twenty-eight Dollars (\$9,024,428.00) or  
17 so much thereof as may be necessary for the financial support of  
18 public schools.

19 SECTION 8. There is hereby appropriated to the State Board of  
20 Education from any monies not otherwise appropriated from the  
21 General Revenue Fund of the State Treasury for the fiscal year  
22 ending June 30, 2021, the sum of One Hundred Million Nine Hundred  
23 Nineteen Thousand Twenty-six Dollars (\$100,919,026.00) or so much  
24

1 thereof as may be necessary for the support of public schools  
2 activities.

3 SECTION 9. There is hereby appropriated to the State Board of  
4 Education from any monies not otherwise appropriated from the  
5 Revenue Stabilization Fund (105 Fund) of the State Treasury, the sum  
6 of Thirty-three Million Dollars (\$33,000,000.00) or so much thereof  
7 as may be necessary for the purchase of textbooks and instructional  
8 materials.

9 SECTION 10. There is hereby appropriated to the State Board of  
10 Education from any monies not otherwise appropriated from the  
11 General Revenue Fund of the State Treasury for the fiscal year  
12 ending June 30, 2021, the sum of Three Hundred Forty-seven Million  
13 Eighty-one Thousand Six Hundred Forty-four Dollars (\$347,081,644.00)  
14 or so much thereof as may be necessary for the Certified Employee  
15 Health Benefit Allowance.

16 SECTION 11. There is hereby appropriated to the State Board of  
17 Education from any monies not otherwise appropriated from the  
18 General Revenue Fund of the State Treasury for the fiscal year  
19 ending June 30, 2021, the sum of One Hundred Eighty-eight Million  
20 Four Hundred Fifty-five Thousand Three Hundred Seventy-seven Dollars  
21 (\$188,455,377.00) or so much thereof as may be necessary for the  
22 Support Personnel Health Benefit Allowance.

23 SECTION 12. There is hereby appropriated to the State Board of  
24 Education from any monies not otherwise appropriated from the

1 General Revenue Fund of the State Treasury for the fiscal year  
2 ending June 30, 2019, the sum of Fifteen Million Twenty-seven  
3 Thousand Six Hundred Forty Dollars (\$15,027,640.00) or so much  
4 thereof as may be necessary for administrative and support functions  
5 of the State Department of Education.

6 SECTION 13. There is hereby appropriated to the State Board of  
7 Education from any monies not otherwise appropriated from the  
8 Oklahoma Education Lottery Trust Fund of the State Treasury for the  
9 fiscal year ending June 30, 2021, the sum of Two Million Six Hundred  
10 Thirty-five Thousand Dollars (\$2,635,000.00) or so much thereof as  
11 may be necessary for transfer to the School Consolidation Assistance  
12 Fund.

13 SECTION 14. There is hereby appropriated to the State Board of  
14 Education from any monies not otherwise appropriated from the  
15 Oklahoma Education Lottery Trust Fund of the State Treasury for the  
16 fiscal year ending June 30, 2019, the sum of One Million Two  
17 Thousand Seven Hundred Fourteen Dollars (\$1,002,714.00) or so much  
18 thereof as may be necessary for transfer to the School Consolidation  
19 Assistance Fund.

20 SECTION 15. There is hereby appropriated to the State Board of  
21 Education from any monies not otherwise appropriated from the  
22 Oklahoma Education Lottery Trust Fund of the State Treasury for the  
23 fiscal year ending June 30, 2021, the sum of Two Million Six Hundred  
24 Thirty-five Thousand Dollars (\$2,635,000.00) or so much thereof as

1 may be necessary for transfer to the Teachers' Retirement System  
2 Dedicated Revenue Revolving Fund.

3 SECTION 16. There is hereby appropriated to the State Board of  
4 Education from any monies not otherwise appropriated from the  
5 Oklahoma Education Lottery Trust Fund of the State Treasury for the  
6 fiscal year ending June 30, 2019, the sum of One Million Two  
7 Thousand Seven Hundred Fourteen Dollars (\$1,002,714.00) or so much  
8 thereof as may be necessary for transfer to the Teachers' Retirement  
9 System Dedicated Revenue Revolving Fund.

10 SECTION 17. There is hereby appropriated to the Oklahoma Arts  
11 Council from any monies not otherwise appropriated from the General  
12 Revenue Fund of the State Treasury for the fiscal year ending June  
13 30, 2021, the sum of Two Million Seven Hundred Ninety-six Thousand  
14 Thirty Dollars (\$2,796,030.00) or so much thereof as may be  
15 necessary to perform the duties imposed upon the Oklahoma Arts  
16 Council by law.

17 SECTION 18. There is hereby appropriated to the State Board of  
18 Career and Technology Education from any monies not otherwise  
19 appropriated from the General Revenue Fund of the State Treasury for  
20 the fiscal year ending June 30, 2021, the sum of One Hundred Thirty-  
21 three Million Four Hundred Seventy Thousand Three Hundred Eighty-  
22 five Dollars (\$133,470,385.00) or so much thereof as may be  
23 necessary to perform the duties imposed upon the State Board of  
24 Career and Technology Education by law.

1 SECTION 19. There is hereby appropriated to the State Board of  
2 Career and Technology Education from any monies not otherwise  
3 appropriated from the Oklahoma Education Lottery Trust Fund of the  
4 State Treasury for the fiscal year ending June 30, 2021, the sum of  
5 Two Million Eight Hundred Ninety-eight Thousand Five Hundred Dollars  
6 (\$2,898,500.00) pursuant to paragraph 2 of subsection F of Section  
7 713 of Title 3A of the Oklahoma Statutes for allocation by the State  
8 Board of Career and Technology Education for the education and  
9 general operating budgets of the institutions and for other  
10 programs, construction, renovations or repairs administered by the  
11 State Board of Career and Technology Education.

12 SECTION 20. There is hereby appropriated to the State Board of  
13 Career and Technology Education from any monies not otherwise  
14 appropriated from the Oklahoma Education Lottery Trust Fund of the  
15 State Treasury for the fiscal year ending June 30, 2019, the sum of  
16 One Million One Hundred Two Thousand Nine Hundred Eighty-six Dollars  
17 (\$1,102,986.00) pursuant to paragraph 2 of subsection F of Section  
18 713 of Title 3A of the Oklahoma Statutes for allocation by the State  
19 Board of Career and Technology Education for the education and  
20 general operating budgets of the institutions and for other  
21 programs, construction, renovations or repairs administered by the  
22 State Board of Career and Technology Education.

23 SECTION 21. There is hereby appropriated to the Office of  
24 Educational Quality and Accountability from any monies not otherwise

1 appropriated from the General Revenue Fund of the State Treasury for  
2 the fiscal year ending June 30, 2021, the sum of One Million Sixty-  
3 seven Thousand Two Hundred Nine Dollars (\$1,067,209.00) or so much  
4 thereof as may be necessary to perform the duties imposed upon the  
5 Office of Educational Quality and Accountability by law. Of those  
6 funds appropriated the sum of Sixty Thousand Dollars (\$60,000.00)  
7 shall be deposited in the Teacher Certification Scholarship  
8 Revolving Fund created pursuant to Section 6-187C of Title 70 of the  
9 Oklahoma Statutes. Of those funds appropriated the sum of One  
10 Hundred Eighty Thousand Dollars (\$180,000.00) shall be deposited in  
11 the Education Leadership Oklahoma Revolving Fund created pursuant to  
12 Section 6-204.3 of Title 70 of the Oklahoma Statutes.

13 SECTION 22. There is hereby appropriated to the Office of  
14 Educational Quality and Accountability from any monies not otherwise  
15 appropriated from the Special Cash Fund of the State Treasury the  
16 sum of Five Hundred Thousand Dollars (\$500,000.00) or so much  
17 thereof as may be necessary to perform the duties imposed upon the  
18 Office of Educational Quality and Accountability by law.

19 SECTION 23. There is hereby appropriated to the Oklahoma  
20 Educational Television Authority from any monies not otherwise  
21 appropriated from the General Revenue Fund of the State Treasury for  
22 the fiscal year ending June 30, 2021, the sum of Two Million Seven  
23 Hundred Twenty-nine Thousand Four Dollars (\$2,729,004.00) or so much  
24

1 thereof as may be necessary to perform the duties imposed upon the  
2 Oklahoma Educational Television Authority by law.

3 SECTION 24. There is hereby appropriated to the Oklahoma State  
4 Regents for Higher Education from any monies not otherwise  
5 appropriated from the General Revenue Fund of the State Treasury for  
6 the fiscal year ending June 30, 2021, the sum of Six Hundred Thirty-  
7 two Million Five Thousand Three Hundred Sixty Dollars  
8 (\$632,005,360.00) or so much thereof as may be necessary for  
9 allocation by the Oklahoma State Regents for Higher Education  
10 pursuant to the provisions of Article XIII-a of the Oklahoma  
11 Constitution for the education and general operating budgets of the  
12 institutions and for other programs, construction, renovations or  
13 repairs administered by the Oklahoma State Regents for Higher  
14 Education. Of those funds appropriated, the sum of Two Million Nine  
15 Hundred Ninety-eight Thousand Four Hundred Seventy-four Dollars  
16 (\$2,998,474.00) shall be transferred to the Oklahoma Tuition  
17 Equalization Grant Trust Fund to implement the provisions of the  
18 Oklahoma Tuition Equalization Grant Act.

19 SECTION 25. The Oklahoma State Regents for Higher Education are  
20 hereby authorized to expend during the fiscal year ending June 30,  
21 2021, the sum of Forty-six Million Nine Hundred Thirty-eight  
22 Thousand Five Hundred Sixty-six Dollars (\$46,938,566.00) from the  
23 Higher Education Capital Revolving Fund of the State Treasury for  
24 allocation by the Oklahoma State Regents for Higher Education

1 pursuant to the provisions of Article XIII-a of the Oklahoma  
2 Constitution for the education and general operating budgets of the  
3 institutions and for other programs, construction, renovations or  
4 repairs administered by the Oklahoma State Regents for Higher  
5 Education.

6 SECTION 26. The Oklahoma State Regents for Higher Education are  
7 hereby authorized to expend during the fiscal year ending June 30,  
8 2021, the sum of Forty-six Million Nine Hundred Thirty-eight  
9 Thousand Five Hundred Sixty-six Dollars (\$46,938,566.00) from the  
10 Oklahoma Student Aid Revolving Fund of the State Treasury for  
11 allocation by the Oklahoma State Regents for Higher Education  
12 pursuant to the provisions of Article XIII-a of the Oklahoma  
13 Constitution for the education and general operating budgets of the  
14 institutions and for other programs, construction, renovations or  
15 repairs administered by the Oklahoma State Regents for Higher  
16 Education.

17 SECTION 27. There is hereby appropriated to the Oklahoma State  
18 Regents for Higher Education from any monies not otherwise  
19 appropriated from the General Revenue Fund of the State Treasury for  
20 the fiscal year ending June 30, 2021, the sum of Eleven Million  
21 Seven Hundred Sixty-four Thousand Eight Hundred Twenty-three Dollars  
22 (\$11,764,823.00) or so much thereof as may be necessary for  
23 expenditures for concurrent enrollment pursuant to Section 628.13 of  
24 Title 70 of the Oklahoma Statutes.

1       SECTION 28. There is hereby appropriated to the Oklahoma State  
2 Regents for Higher Education from any monies not otherwise  
3 appropriated from the Oklahoma Education Lottery Trust Fund of the  
4 State Treasury for the fiscal year ending June 30, 2021, the sum of  
5 Twenty Million Eight Hundred Sixteen Thousand Five Hundred Dollars  
6 (\$20,816,500.00) pursuant to paragraph 2 of subsection F of Section  
7 713 of Title 3A of the Oklahoma Statutes for allocation by the  
8 Oklahoma State Regents for Higher Education pursuant to the  
9 provisions of Article XIII-a of the Oklahoma Constitution for  
10 construction, renovations or repairs administered by the Oklahoma  
11 State Regents for Higher Education or for any other purpose  
12 authorized by paragraph 2 of subsection F of Section 713 of Title 3A  
13 of the Oklahoma Statutes.

14       SECTION 29. There is hereby appropriated to the Oklahoma State  
15 Regents for Higher Education from any monies not otherwise  
16 appropriated from the Oklahoma Education Lottery Trust Fund of the  
17 State Treasury for the fiscal year ending June 30, 2019, the sum of  
18 Seven Million Nine Hundred Twenty-one Thousand Four Hundred Forty-  
19 three Dollars (\$7,921,443.00) pursuant to paragraph 2 of subsection  
20 F of Section 713 of Title 3A of the Oklahoma Statutes for allocation  
21 by the Oklahoma State Regents for Higher Education pursuant to the  
22 provisions of Article XIII-a of the Oklahoma Constitution for  
23 construction, renovations or repairs administered by the Oklahoma  
24 State Regents for Higher Education or for any other purpose

1 authorized by paragraph 2 of subsection F of Section 713 of Title 3A  
2 of the Oklahoma Statutes.

3 SECTION 30. There is hereby appropriated to the Oklahoma State  
4 Regents for Higher Education from any monies not otherwise  
5 appropriated from the General Revenue Fund of the State Treasury for  
6 the fiscal year ending June 30, 2021, the sum of Four Million  
7 Twenty-nine Thousand Four Hundred Eighty-four Dollars  
8 (\$4,029,484.00) or so much thereof as may be necessary for the  
9 general operating budget of the Administrative Offices of the  
10 Oklahoma State Regents for Higher Education.

11 SECTION 31. There is hereby appropriated to the Commissioners  
12 of the Land Office from any monies not otherwise appropriated from  
13 the Commissioners of the Land Office Fund of the State Treasury for  
14 the fiscal year ending June 30, 2021, the sum of Eight Million Three  
15 Hundred Seventy-nine Thousand Two Hundred Seventy-six Dollars  
16 (\$8,379,276.00) or so much thereof as may be necessary to perform  
17 the duties imposed upon the Commissioners of the Land Office by law.

18 SECTION 32. There is hereby appropriated to the Oklahoma  
19 Department of Libraries from any monies not otherwise appropriated  
20 from the General Revenue Fund of the State Treasury for the fiscal  
21 year ending June 30, 2021, the sum of Four Million Three Hundred  
22 Forty-six Thousand Three Hundred Fifteen Dollars (\$4,346,315.00) or  
23 so much thereof as may be necessary to perform the duties imposed  
24 upon the Oklahoma Department of Libraries by law.

1 SECTION 33. There is hereby appropriated to the Physician  
2 Manpower Training Commission from any monies not otherwise  
3 appropriated from the General Revenue Fund of the State Treasury for  
4 the fiscal year ending June 30, 2021, the sum of Six Million Five  
5 Hundred Forty-six Thousand Eight Hundred Seventy-seven Dollars  
6 (\$6,546,877.00) or so much thereof as may be necessary to perform  
7 the duties imposed upon the Physician Manpower Training Commission  
8 by law.

9 SECTION 34. There is hereby appropriated to the Physician  
10 Manpower Training Commission from any monies not otherwise  
11 appropriated from the Special Cash Fund of the State Treasury the  
12 sum of Four Hundred Thousand Dollars (\$400,000.00) or so much  
13 thereof as may be necessary to perform the duties imposed upon the  
14 Physician Manpower Training Commission by law.

15 SECTION 35. There is hereby appropriated to the Board of  
16 Trustees of the Oklahoma School of Science and Mathematics from any  
17 monies not otherwise appropriated from the General Revenue Fund of  
18 the State Treasury for the fiscal year ending June 30, 2021, the sum  
19 of Six Million Thirty-three Thousand Three Hundred Seventy-three  
20 Dollars (\$6,033,373.00) or so much thereof as may be necessary to  
21 perform the duties imposed upon the Board of Trustees of the  
22 Oklahoma School of Science and Mathematics by law.

23 SECTION 36. There is hereby appropriated to the Oklahoma Center  
24 for the Advancement of Science and Technology from any monies not

1 otherwise appropriated from the General Revenue Fund of the State  
2 Treasury for the fiscal year ending June 30, 2021, the sum of  
3 Thirteen Million Seven Hundred Ninety-six Thousand Five Hundred  
4 Forty-two Dollars (\$13,796,542.00) or so much thereof as may be  
5 necessary to perform the duties imposed upon the Oklahoma Center for  
6 the Advancement of Science and Technology by law. Of those funds  
7 appropriated, the sum of Five Million Five Hundred Eighteen Thousand  
8 Six Hundred Seventeen Dollars (\$5,518,617.00) shall be deposited in  
9 the Research Support Revolving Fund, created pursuant to Section  
10 5060.11 of Title 74 of the Oklahoma Statutes. Of those funds  
11 appropriated, the sum of Three Million Thirty-five Thousand Two  
12 Hundred Thirty-nine Dollars (\$3,035,239.00) shall be deposited in  
13 the Seed-Capital Revolving Fund, created pursuant to Section 5060.21  
14 of Title 74 of the Oklahoma Statutes.

15 GENERAL GOVERNMENT AND TRANSPORTATION

16 SECTION 37. There is hereby appropriated to the Office of the  
17 State Auditor and Inspector from any monies not otherwise  
18 appropriated from the General Revenue Fund of the State Treasury for  
19 the fiscal year ending June 30, 2019, the sum of Four Million  
20 Eighty-six Thousand Sixteen Dollars (\$4,086,016.00) or so much  
21 thereof as may be necessary to perform the duties imposed upon the  
22 Office of the State Auditor and Inspector by law.

23 SECTION 38. There is hereby appropriated to the Office of the  
24 State Auditor and Inspector from any monies not otherwise

1 appropriated from the General Revenue Fund of the State Treasury for  
2 the fiscal year ending June 30, 2021, the sum of Two Hundred  
3 Fourteen Thousand Two Hundred Ninety-nine Dollars (\$214,299.00) or  
4 so much thereof as may be necessary to perform the duties imposed  
5 upon the Commission on County Government Personnel Education and  
6 Training. The appropriation made in this section shall be expended  
7 exclusively for the purpose so stated and shall not be transferable.

8 SECTION 39. There is hereby appropriated to the State Election  
9 Board from any monies not otherwise appropriated from the General  
10 Revenue Fund of the State Treasury for the fiscal year ending June  
11 30, 2019, the sum of Nine Million Seven Hundred Thirty-seven  
12 Thousand Six Hundred Seventeen Dollars (\$9,737,617.00) or so much  
13 thereof as may be necessary to perform the duties imposed upon the  
14 State Election Board by law.

15 SECTION 40. There is hereby appropriated to the Oklahoma  
16 Department of Emergency Management from any monies not otherwise  
17 appropriated from the General Revenue Fund of the State Treasury for

11 appropriated from the Digital Transformation Program Revolving Fund  
12 created pursuant to Section 36 of Title 62 of the Oklahoma Statutes  
13 the sum of Six Million Five Hundred Thousand Dollars (\$6,500,000.00)  
14 for availability of appropriation.

15 SECTION 145. There is hereby appropriated to the Education  
16 Reform Revolving Fund created in Section 34.89 of Title 62 of the  
17 Oklahoma Statutes from the Oklahoma Medical Marijuana Authority  
18 Revolving Fund (Fund 248) of the State Treasury, the sum of Thirty  
19 Million Dollars (\$30,000,000.00) for availability of appropriation.

20 SECTION 146. There is hereby appropriated to the State Board of  
21 Education from any monies not otherwise appropriated from the  
22 General Revenue Fund of the State Treasury for the fiscal year  
23 ending June 30, 2019 the sum of One Hundred Twelve Million Dollars  
24 (\$112,000,000.00) to be transferred to the Ad Valorem Reimbursement

1 Fund, created pursuant to Section 193 of Title 62 of the Oklahoma  
2 Statutes, for the purpose of reimbursing counties for school  
3 districts that claim a loss of revenue due to a tax exemption  
4 granted pursuant to the provisions of Section 6B of Article X of the  
5 Oklahoma Constitution.

6 SECTION 147. There is hereby appropriated to State Board of  
7 Education from any monies not otherwise appropriated from the  
8 General Revenue Fund of the State Treasury for the fiscal year  
9 ending June 30, 2019, the sum of Nine Million Eight Hundred Twenty-  
10 four Thousand Three Hundred Fifteen Dollars (\$9,824,315.00) for the  
11 purpose of funding the Teachers' Retirement Credit.

12 SECTION 148. There is hereby appropriated to the Oklahoma State  
13 Regents for Higher Education from any monies not otherwise  
14 appropriated from the General Revenue Fund of the State Treasury for  
15 the fiscal year ending June 30, 2019, the sum of Two Hundred Ten  
16 Thousand Dollars (\$210,000.00) for allocation by the Oklahoma State  
17 Regents for Higher Education pursuant to the provisions of Article  
18 XIII-a of the Oklahoma Constitution for the education and general  
19 operating budgets of the institutions and for other programs,  
20 construction, renovations or repairs administered by the Oklahoma  
21 State Regents for Higher Education.

22 SECTION 149. There is hereby appropriated to the Office of  
23 Management and Enterprise Services from any monies not otherwise  
24 appropriated from the General Revenue Fund of the State Treasury for

1 the fiscal year ending June 30, 2019, the sum of Two Million Four  
2 Hundred Seventy Thousand Dollars (\$2,470,000.00) or so much thereof  
3 as may be necessary for the relocation of the state agencies  
4 currently housed within the Robert S. Kerr and J. Howard Edmondson  
5 buildings.

6 SECTION 150. Sections 1 through 136 of this act shall become  
7 effective July 1, 2020.
