# STATEMENT OF SUFFICIENCY Proposed Initiative 2019-2020 #120

## June 8, 2020

On March 4, 2020, the designated representatives of Proposed Initiative 2019-2020 #120 ("Prohibition on Late-Term Abortion") submitted 137,624 petition signatures to the Elections Division of the Secretary of State. To be placed on the ballot, a petition must have at least 124,632 valid signatures.<sup>1</sup> After reviewing a five percent random sample of the submitted signatures, the Elections Division of the Secretary of State projected the number of valid signatures to be less than 110 percent but more than 90 percent of the total number of signatures required for placement on the ballot. Therefore, the Elections Division of the Secretary of State ordered the examination and verification of each signature filed.<sup>2</sup> The Elections Division of the Secretary of State declared the petition insufficient on April 3, 2020 after determining 114,647 lines were valid. On May 29, 2020, the proponents submitted an additional 48,689 signatures to cure the insufficiency.<sup>3</sup> Upon review, the Elections Division of the Secretary of State has determined that a sufficient number of valid signatures have been submitted and the proposed initiative should be certified to the November 3, 2020 General Election ballot.
