Re-opening Southwark's hospitality sector

July 2020

Background

Due to the COVID-19 pandemic, many businesses were forced to close to prevent the spread of the virus. This forced closure has had an unprecedented effect on these businesses where many have ceased trading and unfortunately in some cases, closed permanently. In a bid to kick start the local economic recovery for the high street / businesses and the management of the streetscape, these businesses are permitted to open and start trading again from 4th July 2020.

The reopening of businesses must be carefully balanced with the need to protect the health and wellbeing of our residents and those using our streets. We must balance the needs of businesses with the needs of residents who may be affected by noise and we must also ensure there is enough space for the public who need to socially distance on our highways.

We want to support businesses as much as we can to get back on their feet. This document sets out the proposals for how Southwark intends to support the reopening of the hospitality sector. The information contained in this document has been produced based on the government's latest guidance and after consultation with key council staff.

Proposal to allow more tables and chairs

We support the government's proposal to make it easier for businesses to safely offer food and drink to their customers outside.

What is the proposal?

The government has introduced the Business and Planning Bill 2020 which will streamline the process for premises to apply for street furniture licence; this will be known as a pavement licence. This new legislation is temporary and applies until September 2021. Further details can be found here:

Can I apply for a new pavement licence now?

Currently the new legislation has not been passed into law, so for the time being if you wish to apply to use tables and chairs or other street furniture on the public highway please use our current forms that can be found here: https://www.southwark.gov.uk/business/licences/roads-and-highway-licences/street-furniturelicence

How does the new bill help businesses?

- It's faster the current licensing process takes over 28 days; the new process will take only 10 working days.
- It's cheaper although the current fees for street furniture licenses in Southwark are relatively low compared to other central London boroughs at £218.30 per annum for up to two square metres of highway space, under the new process, the fee for a licence is capped at £100.

Alcohol

For the purposes of the pavement licence it is assumed you have permission to provide alcohol for consumption as 'off sales'. Contact our Licencing team if you have queries about your premises licence.

What businesses need to know

Keep areas waste free

It's important that the area occupied by street furniture is cleaned on a daily basis by premise owners and kept in a fit state at all times. Southwark Council may ask businesses to provide mobile litter bins on the public highway, if required. Waste deposited into such mobile litter bins will be treated as commercial waste, which may incur additional costs.

Toilets

Existing toilet facilities inside licensed premises must be available for customers; there is no need to provide additional facilities. However this situation will be monitored and the decision may be reviewed and further guidance issued.

Social distancing and signage

It is the responsibility of businesses to put measures in place to keep customers safe. Signage must be clearly posted within the licenced area; this signage must encourage hand washing and the use of hand sanitiser, reinforce social distancing rules, alert customers to the need to reduce noise and the resulting disturbance to neighbours of the premises. Social distancing must be maintained in accordance with the latest government advice.

Insurance

Premises must check and confirm that their use of the outside area is covered by appropriate insurance, including public liability insurance. The Licensee must have obtained public liability insurance to the value of £5 million prior to their occupancy of the public highway

Road Closures

The council will not authorise the closure of any roads for the placement of street furniture by businesses.

Storage of street furniture

Street furniture should be stored in an appropriate place away from the highway when not in use. No outside area will be permitted for use outside the hours of 08:00 and 22:00 and items should be removed from the highway by 22:00.

Applications

Most licence applications will be assessed individually. However in areas with a high density of shops/pubs/bars/restaurants applications may need to be assessed cumulatively.

Protecting the health and well-being of residents

We are working with businesses and directly asking residents to act responsibly and considerately as lockdown is eased, and our small enforcement team will be monitoring compliance and behaviours across the borough, in partnership with the police.

It is our expectation that the majority of businesses and patrons will comply with the new regulations; however, in the minority of incidents where this is not the case, the council have put together a plan on how to respond to any breaches to protect the health and wellbeing of our residents, and those using our streets.

From the 4th July 2020 licensing officers will check if premises are adhering to the government's social distancing guidance, monitor and respond to complaints from residents about nuisance caused by patrons and respond to any safety concerns (e.g. if a premise is blocking a highway with barriers, or tables/chairs).

The initial approach to licenced premises will be one of engagement, education and advice to promote safe practices and reduce the potential for nuisance. We will also find out if premise owners have completed their own risk assessments and discuss what solutions the premises management can introduce to resolve or reduce the impact of their customers on residents. For the very few persistent offenders, where engagement and warnings have not resolved the issues, there are some legislative powers available for enforcement.

If you see any behaviours of concern or if you witness dangerous or illegal behaviour please call the police on 101. If you believe the matter requires an immediate police response call 999.

Licensing:

If residents have concerns about specific licensed premises then they should contact the Licensing Unit via <u>licensing@southwark.gov.uk</u> with full details of their concerns, which will then be investigated and / or directed to the appropriate department. Please note that the Licensing Unit can only provide a reactive service and cannot investigate complaints or concerns at the time that the complaints or concerns are made / raised. Immediate concerns should be raised with the police who have extensive powers including immediate closure that can be invoked.

Noise Nuisance:

Due to the COVID-19 emergency the Council has reduced the noise nuisance service to fall in line with Public Health England guidelines. This means that the Noise and Nuisance team are unable to offer a call out service or attend when a noise nuisance is occurring; however residents should still contact the Noise and Nuisance Team so that their concerns are logged on the council's database. The Noise Team will look at reports coming in, triage them and refer to officers on the ground as necessary.

The Night Time Economy Police

The Night Time Economy Police team work very closely with the Licensing team. Visits are made to premises of concern where complaints have been made, or where there has been criminal activity and/or violence. Contact has already been made with some of our more problematical premises to ensure they have plans in place to open safely. The police also have the powers to enforce the Public Space Protection Order which allows them to confiscate alcohol from people in the street if it is considered to be causing anti-social behaviour

Re-opening our high streets

Clean streets

The council's street cleaning operations have been scaled back since lockdown, however, the cleaning service has continued to provide daily cleaning in retail areas from 6am to 6pm and mobile teams servicing non-retail/residential areas. We are planning on resuming the full cleaning service from Monday 13th July which will see dedicated cleaners replacing mobile teams on nonretail/residential areas. As the hospitality sector reopens, Southwark's Cleaning Teams will monitor the situation and put resources in place to respond to any one-off cleaning issues; we will also liaise with colleagues in Environmental Enforcement if more persistent issues arise.

Social distancing measures

With the aid of the 'High Street Re-opening Fund' we have implemented additional social distancing measures on various roads across Southwark including Rye Lane, East Street and Walworth Road. From 6th July we will be implementing a number of experimental schemes across Southwark to further enhance pedestrian and cyclist safety.

Rye Lane will be closed from the 6th July to allow more space for social distancing for shoppers, cyclists and pedestrians. Work is also underway to create more space for pedestrians and cyclists on and around Walworth Road using permeable closures (closures using planters that block motor vehicles but allow pedestrians and bicycles through), which have also been set up in Dulwich Village, on the junctions with Court Lane and Calton Avenue. All of these will allow safe and healthy routes through this area for the thousands of pedestrians and cyclists who use it every day, including shoppers and students accessing the many local schools. We have also devised a large number of schemes that will help maintain the 2 metre separation. The schemes vary considerably in scope and extent, from simply removing parking and widening footways, to full road closures.

We will also record the activities on the highway and use that information to work out areas of activity that could be controlled by premises having a street furniture licence.
