"In the most recent NFIB survey, a record 44% of small business owners report job openings they cannot fill. They are seeing a growth in sales but are those sales stunted by not having enough workers. Finding gualified employees remains the biggest challenge for small businesses and it is slowing economic growth.

The work-search requirement has been reinstated effective beginning the week of May 23. The additional move to eliminate the augmented \$300 per week in unemployment benefits by Ohio Governor Mike DeWine will help return individuals to the workforce. Short-term payments do not help a long-term jobs shortage problem, and in the long run, people are far better off with good-paying jobs which helps the whole economy recover.

Ohio's economy is growing and growing faster than our neighboring states. We need a robust workforce to maintain our positive trajectory. The time for additional unemployment payments is over. We appreciate Ohio Governor Mike DeWine for recognizing that now is the time to strongly encourage everyone to get back to work."
