### No Appointment Needed

Free COVID-19 testing is available to all LA County residents at drive-up and walk-up testing sites. Appointments are currently not needed, and you are able to register on-site at LA County testing sites. Appointments can still be made and can help reduce wait times.

### Testing highly recommended for:

- People who have symptoms: If you have symptoms of COVID-19, talk to a healthcare provider and get tested.
- People who have been a close contact to someone with confirmed or suspected
   COVID-19 (a case) within the last 14 days. Even if your test is negative, you will still need to complete your quarantine.
- People with or without symptoms who are part of an outbreak response or contact investigation in high-risk settings, such as nursing homes, congregate living facilities, correctional facilities, or persons experiencing homelessness.

# VACCINE & DISTRIBUTION

Starting today, LA County vaccination providers can offer the Pfizer vaccine for 12-15-yearolds. All 8 county sites will be open today for people ages 12 and over. Teens should come with a parent, guardian or responsible adult & bring proof of age. Appointments can be made at VaccinateLACounty.com.
