TESTING

No Appointment Needed

Free COVID-19 testing is available to all LA County residents at drive-up and walk-up testing sites. **Appointments are currently not needed, and you are able to register on-site at LA County testing sites.** Appointments can still be made and can help reduce wait times. Testing highly recommended for:

- **People who have symptoms:** If you have symptoms of COVID-19, talk to a healthcare provider and get tested.
- **People who have been a close contact to someone with confirmed or suspected COVID-19 (a case) within the last 14 days.** Even if your test is negative, you will still need to complete your quarantine.
- **People with or without symptoms who are part of an outbreak response or contact investigation in high-risk settings,** such as nursing homes, congregate living facilities, correctional facilities, or persons experiencing homelessness.

VACCINE & DISTRIBUTION

REOPENING & RECOVERY RESOURCES

As of Thursday, May 6, 2021, Los Angeles County moved into the Yellow Tier of the State's [Blueprint for a Safer Economy framework](#). The State will be keeping its current masking guidance until June 15, and LA County will do the same and remain in alignment with the Los Angeles County Health Officer Order of May 3, 2021. It is important to note that the Centers for Disease Control and Prevention (CDC) announcement last week was not meant to eliminate current safety modifications at local and state levels, and the CDC acknowledged the importance of maintaining local protections.
