## **Tip Sheet: Modified Day Placement and Documentation in ECATS**

The directions for documenting a student's modified day placement in ECATS has been attached to this communication. Please consider establishing local practices to ensure the appropriate use and local monitoring of modified day placements. These placements should be considered short-term in nature, reviewed frequently for appropriateness, and include a plan for transitioning back to a full school day. Also, as a courtesy alert, the use of Home/Hospital and Modified Day placements will be a priority area for fiscal and program monitoring when the new cycle of monitoring begins July 1, 2022. Technical assistance regarding this area and other monitoring priorities will be provided in advance of any public-school unit (PSU) being monitored. (ATTACHED)

# **Program Monitoring Activities - Spring/Summer 2022**

Currently and during the 2020-2021 SY, the Policy, Monitoring and Audit team has worked to complete the modified Program Compliance Reviews and associated corrective action for the PSUs delayed as a result of COVID-19. These efforts were designed to complete the 5-Year Cycle Program Monitoring for the State's PSUs and provide a respite for PSUs during the transition back to in-person learning amid staff shortages.

Program Monitoring Consultants have also collected data through desktop audits for Indicator 11 (Child Find/90-Day Timelines), Indicator 12 (Transition from Part C to Part B), and Indicator 13 (Secondary Transition) for federal reporting required for the State Performance Plan and Annual Performance Report (SPP/APR). The



aggregate data from this monitoring cycle has been analyzed and will inform the new monitoring cycle beginning July 1, 2022. Targeted technical assistance will be provided to PSUs prior to the start of this cycle.

In the interim, some monitoring activities can no longer be delayed and are described below. A great deal of consideration has been given to how and with whom these activities must occur in order to cause as little disruption as possible to PSUs, particularly as the end of the 2020-2021 SY approaches.

## 1. SPP/APR Indicator 13: Secondary Transition

This activity will be conducted using an ECATS virtual desktop audit of IEPs developed during the 2021-2022 SY with an emphasis on secondary transition components only. *No action is required to be taken by PSUs in preparation for monitoring.* 

The selection criteria for PSUs to be included in this sample is based upon the State's aggregate data collected during the Program Compliance Review (PCR) Cycle that occurred between the 2014-2015 SY and 2019-2020 SY.

# PSUs selected for the upcoming Secondary Transition Monitoring are PSUs that:

Achieved < 70% compliance on its Secondary Transition sample when monitored during the PCR cycle;</li>

#### PSUs that will be excluded from the upcoming monitoring are PSUs that:

- Participated in the modified PCR activity during the 2020-2021 SY;
- Remain in corrective action from its PCR visit;
- Do not provide services to student aged 16 or older; and
- Achieved > 71% compliance on its Secondary Transition sample.

The purpose of selecting PSUs for Secondary Transition monitoring based on statewide aggregate data is intended to achieve the following:

- Determine whether corrective action taken at the time the PSU was monitored continue to improve student outcomes for secondary transition;
- Inform statewide targeted technical assistance; and
- Improve postsecondary outcomes for students statewide.

PSUs selected for this activity (approximately 94 PSUs) will be notified by memorandum in the next couple of weeks. In the interim, if there are questions, please contact Carol Ann M. ## 2. Exceeding 1.0 Participation in the NCEXTEND1 Alternate Assessment during the 2020-2021 SY

The Every Student Succeeds Act (ESSA) requires states to ensure that the total number of students assessed in Reading, Mathematics, and Science using the alternate assessment, based on the alternate academic achievement standards, does not exceed 1.0 percent of the total number of all students assessed in each subject.

The North Carolina Department of Public Instruction (NCDPI) anticipated exceeding the 1.0 percent cap on students assessed with the alternate assessment, NCEXTEND1, during the 2020-2021 SY and



requested a waiver of section 34 C.F.R. §200.6(c)(2). As part of the waiver, NCDPI is required to monitor PSUs exceeding the 1.0 percent cap.

PSUs selected for this targeted monitoring activity will be notified by memorandum next week.

EC Directors or Data Managers should review the April 2022 Child Count Report for errors such as duplicate records, incorrect age, grade, setting, and disability. Please remember that when certifying the child count, the EC Director is assuring that all data submitted is accurate.

According to the State Auditors, Directors of Exceptional Children Programs and Lead Administrators of Charter schools must certify the child count data. For this to occur, Directors of Exceptional Children Programs must use their "username" and "password" to log into ECATS to verify and certify the child count data. If the EC Director does not certify the count, a signed and scanned verification form must be submitted to Khalilah O'Farrow-Boulware at <a href="khalilah.ofarrow@dpi.nc.gov">khalilah.ofarrow@dpi.nc.gov</a>. All errors must be corrected, and all Public-School Units must certify their submissions no later than April 22, 2022.

Thank you for your attention to this vital transfer of information. If you have questions regarding child count procedures or technical issues while submitting the child count, please contact ZenDesk.

#### • Important Federal Reporting Reminder: Submission Timeliness

If your district does not certify the data required for Indicators by the due date, your data may be certified by state staff. The integrity of the data is always at risk when the Department of Public Instruction must finalize the data for your district.

#### Revisions to IDEA Grants

When a revision is made to the IDEA budgets (PRCs 049, 060, 070, 185, 186 & 187), the grant narrative Use of Funds must align with the budget. If a Use of Funds revision is needed, it must be made in the narrative Use of Funds section. The PSU can start a revision after the grant has been approved and make any changes necessary for the alignment of the Use of Funds and the budget. The grant revision and the budget revision will be reviewed by the fiscal consultant after submission of the revision. The revision cannot be indicated in the history log.

## Revisions to CARES Act-ESSERF-Exceptional Children Grant (PRC 167)

When a revision is made to the CARES Act-ESSERF-Exceptional Children Grant PRC 167 budget, the grant narrative Use of Funds must align with the budget. If a Use of Funds revision is needed, it must be made in the 2021 CARES Act-ESSERF-Exceptional Children Grant application. The PSU can start a revision after the grant has been approved and make any changes necessary for the alignment of the Use of Funds and the budget. The grant revision and the budget revision will be reviewed by the fiscal consultant after submission of the revision. The revision cannot be indicated in the history log of the grant application.

#### Special Grants

Special grants, with the status of Chief Administrator Approved, are reviewed monthly after the 15th. (If the 15<sup>th</sup> falls on a weekend or holiday, the review will start on the next business day after the 15<sup>th</sup>). Notification of review is made through NC CCIP. For your review, the Special Grants Training recording, along with the PowerPoint are available on the EC Website <a href="here">here</a> under the Special Grants section. Final submission for special grants will be May 16, 2022.

#### • IDEA/ American Rescue Plan Act of 2021 (ARP)

#### American Rescue Plan budgets should be submitted as soon as possible.

The American Rescue Plan funds have been allotted under the following Program Report Codes. The budgets will be submitted the same way as the IDEA budgets. A new application is not required.

#### PRC 185 and PRC 186 Budgets and Allotments Update

The full allotments for PRC 185 and PRC 186 have been released by NCDPI School Business. PSUs should check for discrepancies between the initial planning allotment and the actual allotment. Submitted budgets should be adjusted at this time based on the actual allotment.

#### **Notifications: Unresolved Noncompliance**

The EC Division has recently started sending notifications to PSUs that are within 30 calendar days of its one-year timeline due date for the correction of noncompliance identified through monitoring. In exercising the State's monitoring authority, the NCDPI EC Division must ensure that when it identifies noncompliance with a requirement of Part B of the IDEA by PSUs, the noncompliance is corrected as soon as possible, and in no case later than one year after the State's identification of noncompliance. §300.600(e)

Unfortunately, despite grace periods, extensive technical assistance and additional flexibility provided as a result of COVID-19, some PSUs are coming to the end of their corrective action timeline with far too many pending activities left to resolve in a timely fashion. While the current notifications have been currently tied to corrective action associated with Program Compliance Reviews, this standard operating procedure will likely be extended to any EC Division activity that requires a corrective action timeline. More details will be provided about this process in the coming weeks.

#### PRC 029 Funds 2022-2023 Updates

Please review your 2021-2022 PRC 029 budget and ensure all funds will be encumbered by **June 30, 2022**. The original date for reversions was April 1, 2022. If your PSU will have an excess of funds, please revert the funds no later than April 15, 2022. Please see the attached reversion form. **(ATTACHED)** 

#### PRC 029 Request for Funding for Fiscal Year 2022-2023

The application process for the PRC 029 grant is currently open for the 2022-2023 school year. A special budget provision in the 1999 Appropriation Act modified the use of these state dollars to allow expenditure of PRC 029 funds to provide services to "(i) children with special needs who were identified as members of the Willie M class at the time of dissolution of the class, and (ii) other children with special needs." This provision provides the flexibility for PSUs to use these PRC 029 funds for services for students who have significant behavioral and emotional needs in public schools.

This application process will allow PSUs to complete a Comprehensive Needs Grant. The application process will open on **May 1, 2022.** Please note the final submission deadline is **July 1, 2022**.



The application requires each PSU to identify services and indicators that measure the effectiveness of these supports. Prioritization will be given to innovative grant proposals that are designed to address the critical need for identified students.

All students eligible for PRC 029 services must have a completed <u>Entrance Tool</u>. The Entrance Tool must be submitted during the time that the grant is open.
