**ORDER CANCELING SCHEDULING CONFERENCE AND ESTABLISHING REVISED
PROCEDURAL SCHEDULE**

On November 2, 2021, Interstate Power and Light Company (IPL) filed with the Utilities Board (Board) an application for advance ratemaking principles, waiver of reorganization requirements, and limited waiver of energy adjustment clause requirements for 475 MW of solar projects and a battery energy storage system.

On January 25, 2022, the Board issued an order establishing a procedural schedule. On April 5, 2022, IPL filed a motion to extend the procedural schedule. On April 6, 2022, the Board issued an order addressing motion to extend procedural schedule.

In the April 6, 2022 order, the Board requested a joint proposed procedural schedule to be filed by April 18, 2022, which included potential hearing dates of August 8-10, 2022. The order also set a scheduling conference for April 22, 2022, to establish a new procedural schedule.

On April 15, 2022, IPL filed a joint proposed procedural schedule. In the April 15, 2022 filing, IPL states it “conferred with the parties to this proceeding who stated in writing that there is no objection to the Joint Proposed Procedural Schedule set forth in the table below.”

The Board has reviewed IPL's filing and sets forth the revised procedural schedule included as Attachment A, which is incorporated into this order by reference. Parties will be required to identify each witness who will testify at the hearing and the order of witnesses by July 25, 2022.

In the April 6, 2022 order, the Board rescheduled two technical conferences to May 26 and July 7, 2022. Due to the technical conferences being rescheduled, the Board will require parties to file notice of whether they will participate in the technical conferences by May 16, 2022. The technical conference will be livestreamed. Parties will find instructions for participating on the Board's Hearing and Meeting Calendar page at iub.iowa.gov.

IT IS THEREFORE ORDERED:

1. The April 22, 2022 scheduling conference is canceled.
2. By May 16, 2022, parties shall file a notice of participation for the May 26 and July 7, 2022 technical conferences. Instructions for parties to participate remotely will be available on the Board's Hearing and Meeting Calendar page at iub.iowa.gov.
3. By July 25, 2022, parties shall file a list containing the name of each witness and the order of witnesses.
4. An evidentiary hearing for the presentation of evidence and the cross-examination of witnesses shall begin at 9 a.m. August 8, 2022, in the Utilities Board's Hearing Room, located at 1375 E. Court Ave., Des Moines, Iowa. A revised procedural schedule is established as shown in Attachment A to this order, which is incorporated into this order by reference.
