Homebound/Hospital Attendance Code

As previously communicated, a new H/H Attendance Code will go live in PowerSchool on July 1, 2022. The attached technical assistance guide is intended to illustrate appropriate use cases for this code, provide responses to the FAQs submitted since announcing the upcoming release of the code, and an explanation of the documentation necessary to support a homebound/hospital placement through medical necessity or IEP Team decisions. Please be aware that this information is also being shared concurrently with other appropriate district personnel. **(ATTACHED)**

Homeroom with Education Leaders Webinar: Building Robust Summer Development Opportunities for the Special Education Workforce

The COVID-19 pandemic upended the American education system and highlighted the greatest areas of need, especially for students with disabilities and their teachers. Some students with disabilities lost the additional supports and services they require to access the curriculum during virtual learning, putting them behind academically as schools returned to in-person learning. As special educators prepare for the new school year,



they will need rigorous professional development to support them in meeting the needs of students with disabilities. ECATS: "Per Reporting Period"

"Per Reporting Period" will no longer be an option to describe the frequency of special education and related services in ECATS as of **July 1, 2022**. To support the transition away from the use of this frequency, an overview of the micro PD session titled "Determining Service Delivery" will be presented during the **June 21st EC Director's Webinar** along with an overview of the Tip Sheet: "Interruptions in Service". The tip sheet will provide technical assistance regarding whether compensatory services are required as a result of unique events that interrupt the service delivery of special education and related services. Once shared during the EC Director's Webinar, the technical assistance materials will be released to PSUs via the following Weekly Update.

EC Directors are **highly encouraged** to invite local lead related service and low incidence personnel to participate during this portion of the Director's webinar. This content will be provided at the beginning of the session in order to accommodate the participation of additional personnel who then can be released once the content has been provided. A mechanism for collecting questions will be provided during the webinar with responses provided through an FAQ and/or a possible EC Office Hours session.

Please note that the content of "Determining Service Delivery" will focus on the interrelationship between special education, related services, supplemental aids and services, program modifications and support for school personnel. This micro PD is not designed to demonstrate how to calculate the conversion of "per reporting period" frequencies to daily or monthly services; rather, it is intended to provide essential components to consider when services must be provided more frequently in order to meet IEP goals and other services that are less frequent to support access to all settings.

• Indicator 12 Spreadsheet

Indicator 12 captures data on students who received Part C services and were referred to Part B during the July 1, 2021 through June 30, 2022 reporting period. Indicator 12 must be submitted via spreadsheet by all Traditional Public School Units prior to the due date of October 31, 2022. Charter Schools and State Operated Programs do not need to submit an Indicator 12 spreadsheet this year. • Revisions to IDEA Grants

When a revision is made to the IDEA budgets (PRCs 049, 060, 070, 185, 186 & 187), the grant narrative Use of Funds must align with the budget. If a Use of Funds revision is needed, it must be made in the narrative Use of Funds section. The PSU can start a revision after the grant has been approved and make any changes necessary for the alignment of the Use of Funds and the budget. The grant revision and the budget revision will be reviewed by the fiscal consultant after submission of the revision. The revision cannot be indicated in the history log.

• Revisions to CARES Act-ESSERF-Exceptional Children Grant (PRC 167)

When a revision is made to the CARES Act-ESSERF-Exceptional Children Grant PRC 167 budget, the grant narrative Use of Funds must align with the budget. If a Use of Funds revision is needed, it must be made in the 2021 CARES Act-ESSERF-Exceptional Children Grant application. The PSU can start a revision after the grant has been approved and make any changes necessary for the alignment of the Use of Funds and the budget. The grant revision and the budget revision will be reviewed by the fiscal consultant after submission of the revision. The revision cannot be indicated in the history log of the grant application.

ECATS Progress Monitoring Tool (Repeat from 6.6.22 Monday Message)

As we review and revise our user experience with ECATS, we have undertaken efforts to automate short-term objectives/benchmarks to populate the steps in the progress monitoring tool. We have a tentative target date of Fall of 2022 for this functionality in the system. More information, including a Tip Sheet and/or TA video, will be provided once the target date has been confirmed. For PSUs that have adopted the practice of using objectives/benchmarks for IEPs beyond the students served via the adapted curriculum, this functionality is expected to streamline use of the progress monitoring tool to reduce the manual entry of "steps".

PRC 029 Funds 2022-2023 Updates

Please review your 2021-2022 PRC 029 budget and ensure all funds will be encumbered by **Thursday, June 30**, **2022.**

PRC 029 Request for Funding is now OPEN

The application process for the PRC 029 grant is open for the 2022-2023 school year. A special budget provision in the 1999 Appropriation Act modified the use of these state dollars to allow expenditure of PRC 029 funds to provide services to "(i) children with special needs who were identified as members of the Willie *M* class at the time of dissolution of the class, and (ii) other children with special needs." This provision provides the flexibility for PSUs to use these PRC 029 funds for services for students who have significant behavioral and emotional needs in public schools.

This application process will allow PSUs to complete a Comprehensive Needs Grant. The final submission deadline is Friday, July 1, 2022.

The application requires each PSU to identify services and indicators that measure the effectiveness of these supports. Prioritization will be given to innovative grant proposals that are designed to address the critical need for identified students.

All students eligible for PRC 029 services must have a completed <u>Entrance Tool</u>. The Entrance Tool must be submitted during the time that the grant is open.

ATTENTION NC Pre-K Rule Change Effective April 2022 with Implementation Beginning September 2022

The Division of Child Development and Early Education (DCDEE) is excited to share information about a child care rule change effective April 2022.

Child care rule 10A NCAC 09 .3013 NC Pre-K Teacher Assistant Education and Credentials has been amended. The revised rule language requires all teacher assistants hold a Child Development Associate (CDA) credential; or hold or be working toward an associate degree or higher in birth-through-kindergarten, child development, early childhood education, or an early childhood education related field. Teacher assistants working toward the associate degree shall make progress by completing a minimum of six documented semester hours per year. Additionally, all NC Pre-K Teacher assistants shall complete at least 15 hours of annual in-service professional development.

Please note that Child Care Rule Section .3013 – NC Pre-K Teacher Assistant Education and Credentials only applies to teacher assistants working in NC Pre-K classrooms.

Over the next few months, technical assistance will be provided to assist programs with meeting the requirements in this rule. For specific questions regarding these changes, contact your child care licensing consultant or your local NC Pre-K contractor. Also, please ensure you are using the updated April 2022 Child Care Rules.
